AFWD Overview

- Operating workforce development programs since 1986
- WIOA provider in 6 Northern California Counties
 - Butte, Lassen, Modoc, Nevada, Plumas, Sierra
- 15,264 square miles
- Larger territory than 9 States
 - NH, NJ, VT, CT, RI, DE, MD, PA, HI
- 8 – America's Job Center of California
- 103,000 visitors to our One Stops

Northern Rural Training and Employment Consortium (NoRTEC)

- Workforce Development Board, formed through a Joint Powers Agreement between 11 Counties
- Contract with service providers to deliver WIOA services at county level
- CalJOBS
- Contract compliance
- Performance reporting
- Vision- ***“Partners combining their diverse strengths to support healthy and thriving communities.”***

[WIOA Vision]

- Partnership and program alignment, with common, unified regulations across the partners
- Increase system access

[Partnership with AEBG]

- AFWD applied for AEBG funds in 15/16 and 16/17 to deliver workforce solutions for Plumas County

[How did we do it??]

- Regional Coordinator

[Why CalJOBS?]

- Central point of data collection for WIOA
- Reporting of required elements for AEBG
 - Demographic, certificate attainment, employment stats, activities, follow-up data
 - Look at data from overall consortium and provider specific
- WIOA performance outcomes
- Did not have to create another database
