BUILDING SUMMARY

3525 Laburnum Drive, Trail

"Waneta Manor Apartments" is a three storey, 50 unit apartment building located in Trail, close to bus transportation through an underground pathway and easy access to the highway. It is wood construction with aluminum exterior which was re-painted three years ago, and has a torch on roof that was replaced in 2012. It sits on a nicely landscaped, extremely large lot that backs unto a greenbelt, and has an underground irrigations system for the lawn. The well-lit, underground parkade has key code entry and a security gate.

There is a John Wood storage tank, as well as a spare John Wood hot water tank for the domestic hot water and a Bosch tank-less hot water system for back up. The electrical box is circuit breakers. The fire system has also been recently replaced. The building also has two cooling/heating systems on the roof that ventilate the hallways year round.

The covered entrance has an intercom system and leads to the lobby and mailboxes. The hallways are air conditioned and are tastefully decorated with carpeting and framed art. The building has an original Otis hydraulic elevator.

There is a laundry room on each floor with two Whirlpool washers (replaced approximately three years ago) and two Whirlpool dryers in each room which are owned by the building. Lots of extra rooms include a mechanical room with desk and tools, another large woodworking shop and a good sized office.

Units have hard wired smoke and heat detectors, intercoms, electric heat, and hardwood floors with carpeting on top. The kitchens have 30" frost free fridges, 30" stoves (in the 2 and 3 bedroom units), original cabinets with arborite countertops, and lino flooring. Bathrooms have ceramic tile tub surrounds, lino floors, large vanities and most toilets have been raised 18" for seniors. As well as large closets and lots of in suite storage, there are 32 storage lockers available. The balconies have double glazed patio doors, concrete decks and aluminum railings. Some of the suites have a view of Red Mountain.
