#### notes and comments

New bylaws have been passed that set limits on maximum house sizes. These set to go into
effect until January. In Rs3 zoning paragraph 203.6 Floor Area Ratio will be changed as follows:
Current RS3 Floor Area Ratio (section 203.06)

- (1) 0.35 of site area maximum, if site area is greater than 677 square metres; or
- (2) 237 square metres maximum, if site area is between 474 and 677 square metres; or
- (3) 0.5 of site area maximum, if site area is less than 474 square metres

Proposed RS3 Floor Area Ratio (section 203.06) to become effective Jan 2021

- (1) 0.30 of site area maximum, if site area is greater than 681.3 square metres, to a floor area maximum of 585.4 square metres; or
- (2) 206.2 square metres maximum floor area, if site area is between 408.8 square metres and 681.3 square metres; or
- (3) 0.5 of site area maximum, if site area is less than 408.8 square metres

Difference in Allowable Floor Area

current zoning allows FSR 0.35 or 390.6 m² (4204 SF) buildable area

proposed zoning allows only FSR 0.30 or 334.8 m<sup>2</sup> (3603.8 SF)

the proposed changes to zoning will reduce the builable area of the site by 55.8m2 (600.6 SF)

- The new bylaws will also allow more coachhouses. There is potential for a coach house on the site. Floor area used to create a coach house would be counted as part of the total allowable floor area for the site.
- 100% of a basement is exempt where grade is within 0.9m (2'-9")of the main floor level; and basement area that is partially below grade is partially exempt. The potential basement area noted above is a practical estimate given the square footage of the potential floors above, which are counted as FAR.
- 4. This property is not subdivideable. The current site area is less than the current minimum lot size of 1115m2 or 12,000 SF
