Minutes of Last Meeting

Minutes from the March 2010 Board meeting were accepted unanimously.

Treasurer's Report

Treasurer's Report for April was accepted unanimously. Balance in the account as of April 13th, 2010, is \$6,006.90. Year-To-Date as of April 13th, 2010: Total income of \$5,593.41, total expenses of \$2,640.51, for a total income to expenses of \$2,952.90. Storage Unit is paid through June. At the April Meeting, A representative from Community Health Free Medical Clinic will be present to accept their check for the Chili Challenge. The ATM card is be the responsibility of the Treasurer with the President and Vice President also knowing the pin code.
