MINUTES OF THE LAST MEETING

Minutes from the February 12, 2013 Board meeting all approved.

TREASURER'S REPORT

The Treasurer's Report for the period of 02/01/13 through 02/28/13 was presented by Steve Robe. The beginning balance on 02/01/13 was \$5,495.55. Expenses Totaled \$3,505.67. Total Income was \$12,069.74. The ending balance on 02/28/13 was \$14,059.62. This report was unanimously approved by the Board.

CHILI CHALLENGE

Expense reports for the Chili Challenge were presented by Kate Sanders and approved by the Board. Kate Sanders said a survey was taken to get ideas for how to improve the Chili Challenge. The Board gave approval for our club to continue participating in the Chili Challenge.

ST. PATRICK'S DAY PARADE, March 17, 2013

We have beads for the parade. Jim Roman made a tiki bar that will go on a trailer. We are entry number 36. A meeting place and time has been set up for those who want to participate.

DUBUQUE BUS TRIP, April 27, 2013

A \$100 deposit needs to be made for the bus. We have 28 people signed up so far. For those who want to go on the bus trip, payment is needed by the April OPH.

AUTISM SOCIETY WALK, April 27, 2013

We would like J.B. present during this event. Sue Anderson will order blue beads for us to distribute during this event. April is Autism Awareness Month.

CLUB BIRTHDAY PARTY, May 5, 2013

Our club's birthday will be celebrated at City Beat from 3 to 8 p.m.. Jerry Gontag and Mike Broward will provide live music. No drink tickets since the live music is our "gift". Sue Anderson will get a ½ sheet birthday cake. City Beat will pay for half of the entertainment and our club will pay for the other half – this will be \$200 each. Bart made a flyer for the event and Randy will show the flyer to Julie at City Beat. We are to come up with award ideas. The Parrothead of the Year will be announced at this event. Further planning for this event will be discussed at the next Board Meeting.

2013 PHLOCKING

Eastern Iowa Honor Flights was chosen as our main charity for the 2013 Phlocking. This organization covers seven Iowa counties. They have upcoming flights scheduled for April and May. Sue suggested greeting vets at the airport and to promote the Phlocking. One or two more smaller charities will be chosen for the Phlocking. They will be chosen at our next Board Meeting.

It was decided that tickets for the Phlocking will be \$20 each in advance. At the club's birthday party on May 5, tickets will be available for \$16.00 each for one night only. They must be purchased in person and paid for that night.

A Phlocking Memorandum of Understanding was present to the Board by Bart. The purpose of it is to inform a charity of the ways that it is expected to support our club's efforts to succeed in having a successful Phlocking fundraiser. The only change suggested made to this agreement that four Or more volunteers be provided for the Phlocking. This memorandum was then approved by the Board.

The Board discussed having a drawing for a basket for those members who volunteer to help out at the Phlocking. We also discussed having a special lanyard for Phlocking volunteers.

There are six committees that will be needed to organize the Phlocking. Bart suggested that a Board member can act as a "go-between" between the committee chair and the board. Sue volunteered to

represent the Auction Committee; Penny volunteered to represent the Decorating and Special Events committee along with Tina who will be in charge of the "Booze Wall". Tom will represent the Volunteer Committee. This leaves the Pre-Party Committee, the Publicity/Promotion Committee and the Sponsorship Committee left to have a board member to represent them.

Phlocking Committee Budgets will be set at the next meeting.

Phlocking Auction donation cards will be made by the Sue. Each card will have a business name on it. A club member will contact the business on the card to request a donated item for the Auction at the Phlocking. If they succeed in getting a donated item, the card will go into a drawing for a prize.
