## **Improving And Celebrating Our Parks**

Lakewood's parks and greenspaces are rightly treasured and highly used by our residents. The City of Lakewood is always working to ensure that these jewels are consistently maintained. We also regularly evaluate how the parks are used, what updates are needed, and opportunities for improvements based on resident priorities and needs. This year, our Planning and Development Department is once again working through community input and engagement on potential updates to multiple parks.

At Lakewood Park, we are working through development of a Waterfront Access Plan that aspires to increase public access and exposure to our city's greatest natural asset – Lake Erie. Outreach has been ongoing for months, and the City and our design team from SmithGroup recently hosted an open house that drew dozens to offer feedback on renderings of the proposed plans. The recommendations include exciting ideas to achieve the goal of building the connection between the people of Lakewood and our Great Lake. You can see the concepts here: https://www.lakewoodoh. gov/lakewood-park-waterfrontaccess-feasibility-study/. The City is excited about the potential to achieve this plan and will continue to refine it as we explore how to fund the recommendations.


We are also completing another planning process for Lakewood's second largest city park, Madison Park. The result of this work, and partnership with the Cuyahoga County Planning Commission, is a master plan that lays out the future vision for this important and heavily used community asset. Once again, the team at City Hall was successful in securing outside funding for the plan, with over 85% of the costs coming from a Cuyahoga County Planning Commission grant. We expect the master plan to be adopted this Spring.

Even as we position our largest parks for maximum benefit, the City also is highly focused on our neighborhood parks, and public input is essential there as well. A communitywide online survey and an in-person meeting at Cove Community Center were both concluded recently regarding Merle Bunts. For Niagara Park, planning outreach is open now through an online survey and a public workshop on Tuesday March 26th from 3:30pm - 5:30pm in the Hayes Elementary School library. We all look forward to the ideas that develop to

A healthy tree canopy has multiple benefits – from addressing stormwater volume and helping to clean the air to carbon mitigation and simply making Lakewood a more attractive place to live. Let's all continue to do our part to care for and improve the health of Lakewood's trees.

## Three Meetings At City Hall

The Public Safety Committee heard presentations from and asked questions of Law Director Ernie Vargo and Chief Prosecutor Myriam Miranda regarding changes to Section 513.01 of the Codified Ordinances as it pertains to Adult-Use Marijuana. Director Vargo explained that a group in the Law Department has been meeting to work on this section and expects to have a final draft prepared for Council to review in 4 - 6 weeks. Ms. Miranda assured the committee and members of the public that police officers would be trained and given updated protocols as Lakewood adapts to the legalization of Adult-Use Marijuana.

The Housing, Planning, & Development Committee discussed a number of city-owned properties that the city is looking to sell by partnering with a licensed real estate broker. The committee failed to send this action item along to council for approval because of Committee Chair Thomas Bullock's apprehension around selling the property at 1450 Belle Ave. The brick building across Belle from the pit that used to be Lakewood Hospital has housed offices of the Cleveland Clinic as well as the Lakewood Child Care Center. The Chairman seemed truly troubled by the prospect of selling the parcel as he

reminisced aloud about negotiations to procure it during the closing of the hospital. Bullock was under the impression that collecting rent from tenants there was a source of income for Lakewood and did not want to agree to part with the building if it was adding to the bottom line. Director of Planning & Development Shawn Leininger stated that the city is spending "hundreds of thousands of dollars" to maintain the building and that it is a risk for the city citing the condition of the edifice. Leininger also cited insurance cost as a point against keeping

the property in the city's real estate portfolio. This agenda item was deferred and will be revisited the next time the committee meets.

The City Council Meeting lasted 13 minutes and was over at 7:49 pm. The longest discussion on any one item was a resident's concern about a \$458 charge for a sidewalk repair in front of his house. He stated that when he initially asked about the sidewalk when it was marked for repair with spray paint by the city he was told that there was no issue with it and it would not

be repaired. One year later when the homeowner was out of town he received a phone call stating that the sidewalk was going to be repaired at his expense. Public Works Director Chris Gordon addressed the gentleman at Council President Sarah Kepple's prompting and confirmed the stated timeline of events. He offered to speak with the concerned citizen directly after the council meeting to resolve the issue and he did do so. After the respectful exchange Mayor Meghan George explained that this public comment highlighted a known issue in the Public Works Department. She expressed a desire to improve the Sidewalk Replacement Program, implying that there have been other instances of marked sidewalks not being visited by workers in a timely manner.

The three meetings started ten, five and six minutes late respectively. There seemed to be little regard for punctuality despite the triple-header on the schedule. One member of council even walked over to me to shake my hand at 6:07. My bicycle seat would have had a few fewer snowflakes on it at the end of the night if everyone had been seated and ready to start on time.

### **Lakewood Prevails In OHSAA Finals**

#### March 2: Lakewood Rangers vs Hudson Explorers

To beat a tough and physical Hudson squad, the Lakewood Rangers needed to play with peak level effort and mental toughness. They did just that, and after 32 tense minutes, behind a great team effort and some clutch plays, the Rangers prevailed in the OHSAA Sectional Final 58-55.

Lakewood held a small lead most of the way, but when the Explorers finally took the lead late in the 3rd quarter, junior guard Luke Vannucci (13 points) cooly hit a transition 3 pointer from the top of the key--perhaps the most important basket of the game-- halting Hudson's momentum and calming their increasingly engaged fans. From there, junior guard Lucas Seguine

used his superb ball handling skills to score 6 of his game high 16 points in the decisive fourth quarter. Great team defense on the last two Hudson possessions meant a win for Lakewood and a welcome reprieve from a nail-biting overtime period. The three senior starters, in their last game at the East Gym, played strong at both ends. Jack Gowan (11 points) cashed in three 3 pointers, had two steals, and helped

Dominic Peck (6 points) scored 4 critical points late, each time pushing the Lakewood lead to 3 points. Senior Drew Jablonowski was vintage Drew, fiercely battling for rebounds against the much larger Hudson squad, finishing strong at the rim (14 points), and, most of all, setting a tone--and standard--of intensity that lifts the whole team. It was all hands on deck today--the student section was all that and more--loud, proud, positive and engaged. The pep band and cheer squad did their part and then some. The whole Ranger family seemed to adopt our Softball teams mantra--Mudita--an ethic that celebrates the achievements of others. Hats off to Hudson, like Lakewood a community-based team that played hard and represented their school and town well. Congratulations to Coach Cammock, his staff, and of course the players for their never back down attitude. The Rangers go to Twinsburg to face St. Ignatius Wednesday night in the District Semi-Finals. The squad from 44107 are decided underdogs, but of course one thing is assured—our Lakewood Rangers are one team, from



## What Would Jesus Do?

"It's like looking up the skirt of the Catholic Church," my sister remarked as we flipped through the catalog where you could buy: Mass. From the communion wafers—the body of Christ—to the Crown of Thorns, all of it: for sale.

I went to church every Sunday for eighteen years of my life. As a kid, I distanced myself from most of what was said on the altar by using sign language to have conversations with my sister, or lip-syncing what priests recited weekly.

As a teen, I pinpointed why I tuned out. How the words from the altar didn't embody the fullness of things we could be talking about: The complexity of this messy, human experience and finding meaning, compassion, and love amidst it all. Nor speak to me as a woman—not reflected in leadership, rights not championed.

And so sign language turned to Sundays driving around and getting donuts—not forgetting to grab the flyer from St. Malachi's or St. Luke's to prove I'd gone to church.

But there were moments when they had me: Listening to a homily by Father Hritz at St. Malachi's where he told a story, spoke from the heart. From the voice of love.

And too late I'd learn that was what the whole thing was about—what

Jesus himself embodied—before power obstructed the view and led the Church to dangle the keys to proving one's worthiness through strict rule-following to build power to hold itself together. Instead of softening, evolving to continually channel the voice of compassion and love. The voice of Jesus.

The moments with the Father Hritz's of the world were too few and far between and the dissonance between loving people who were cast as sinners—loved who they loved, lived with who they loved unwed, chose not to become a mother when they weren't ready—too great. I left the church all together.

It was easier to leave behind than the stories I had swallowed of where I should feel shame. Those would take me into my 40s to shed.

When I read about the Cleveland Catholic Diocese's new policy\* a few weeks ago around gender-affirming care and LGBTQ rights, I wondered whether the dissonance that caused me to leave might be growing for some still part of it.

Reading about a policy that is developmentally inappropriate: My three-year-old son (until he tells me otherwise) wears a dress 30 percent of the time. I blushed when he first wore his sisters' hand-me-down sparkly dress to their soccer games—the grooves of my own conditioning deep.

But I learned from the early childhood experts in preschool who greeted him with openness, "I love your dress." Who doesn't want to sparkle?

And an all-out war on the LGBTQ community still connected to the Church: the contours of the policy incenting a modern-day witch hunt.

I was reminded of flipping through the catalog that day. The moment I pulled back the curtain on the wizard and realized Catholicism is not just a faith but also a business. With a budget for things like: communion wafers, the Crown of Thorns, payroll.

And when the Diocese of Cleveland refuses to evolve—engage in better business practices—patrons can boycott the business part—even while keeping their faith. Show up outside on Sundays in service of returning to compassion; or in tough conversations with parishes, instead of passive in the pews. With-

hold donations and tuition dollars to Catholic schools until the organization reflects Christian values. Give the Diocese a chance to course-correct, choose compassion and love—find Jesus.

Before everyone takes their business elsewhere.

It feels far afield—standing outside churches with signs on Sundays, withholding money until we're sure it's being used to reflect Christian values—and yet reminds me how different love can look. It makes me wonder: What would Jesus do?

(\*Ed's note: The policy prohibits staff and students from undergoing genderaffirming care, using pronouns different than those affiliated with a person's biological sex and compelling church/school staff members to tell the parents of a child who might be transgender)

## Tornado Season Starts Early In Ohio

The weather this past week in Ohio has done just about everything.

Warm and sunny, beautiful early Spring days to violent hail-producing thunderstorms with torrential down-pours. Unfortunately, it also saw eight tornadoes destroying homes, barns, and most importantly life. Three people lost their lives in Indian Lake in Logan County when an EF2 tornado swept through in the night with winds of 136 mph. Over 20 people were hospitalized with various injuries.

Jim and I drove down to Plymouth on the edge of Crawford/Richland Counties to see how much damage had happened there. We found a destructive trail through farmland that was over ten miles long. We saw debris scattered over pristine fields that are ready to be planted. Metal roofing from barns and out buildings was strewn and twisted everywhere, up in the trees that were still standing and all over the countryside. The shearing off of trunks from mature trees was unbelievable. Most trees were twisted beyond saving.

We met Casey and his father-inlaw who lost everything. The house was gone. Their barn was gone. The doublewide that was parked out back was found on the neighbor's property tossed over a tall natural tree/brush barrier. It was smashed, twisted and a total loss. The front porch of their home was all that was left. The good news is that there were no fatalities in Plymouth. Everyone there was okay, including their livestock. The father and son-in-law were not there that evening. They were just grateful to be alive and safe. "Everything can be replaced, we have our family, that's all that matters," he said.

The turnout of the community was inspiring to see. Everyone with a tractor and a tool belt showed up to help their neighbors out. Clearing roads, piling debris, putting on temporary roofs and whatever else was needed for people to remain in their homes. More rain was expected. But for the grace of God. Prayers were said and answered that day.

The communities hit are going to be picking up the pieces for a long time. Literally.

Insurance claims were made, adjusters were out, and rebuilding was happening. It all takes a toll on people's lives and their livelihood in rural Ohio. It could just as easily have occurred here in Lakewood. In such a densely

populated area, we may not have been so lucky.

As storms become more severe every year, everyone should take the time to become prepared. Make sure your home and/or renter's insurance is adequate and up to date. Take a walk-through video, showing and describing your belongings if you have to do a claim. Have an emergency plan for your family and pets: a specific place

designated in the basement away from windows, the furnace and hot water heater. If no basement is available, then under the stairwell or in an interior closet is the next best. Get in the bathtub if all else fails.

Keep your important papers together. This can't be stressed enough; a safe box or even if it's just a folder that you can grab and keep with you. It should include your policies, mortgage note/deed, passports, birth certificates, marriage licenses, and anything else you consider important and difficult to replace.

As far as your property goes, if you have warning and time, secure as much as possible. Put the car in a garage, rope all of your patio furniture together tightly to help prevent it from taking off. Put garbage cans, BBQ grills and potted plants in the garage as well. Always...always have at least a few days of food and water on hand for your entire family.

If you are a victim of storm damage, take photos of the damage in and out and report it asap.

We know Lakewood will turn out to help its neighbors, it has in the past and will again. Let's just hope it's not in the near future.

## What You Should Know **About Credit Scores And Bankruptcy**

Most consumers know that credit scores and bankruptcies can impact their financial well-being but don't understand how. Credit scores can determine whether someone can get a loan and if their interest rates will be low or exponentially high. There are things that consumers should be aware of to keep their finances stable.

One area that causes confusion for consumers is how to dispute discrepancies on their credit report.

"You can write a letter to the three credit bureaus - Equifax, Experian and TransUnion- that includes documentation to show the bureaus that their reports are incorrect," said Matt Alden, a Senior Attorney in the Economic

Justice Group at The Legal Aid Society of Cleveland. "The credit bureaus would then have 30 days to investigate the inquiry and write a response to the consumer stating that they will delete, keep, or change the error on the report. If the credit bureaus will not change the incorrect information, the consumer can hire an attorney and respond to the bureaus according to the Fair Credit Reporting Act."

Credit pulls can also impact your credit score. Hard pulls are made when you want to borrow money from a lender for car and home loans or when applying for new credit cards. Too many hard pulls can decrease your credit score. Soft pulls are made when a company pulls your credit to verify your name, address, work history, payment history, if you filed for bankruptcy and more. Some soft pulls are made without the consumer's permission. An example of this is when you receive mail from auto and home insurance, credit card and loan companies. These companies have already pulled your credit to determine that you pre-qualify for their offers. Soft pulls don't affect your credit score.

Another area that consumers struggle with is bankruptcy.

"You should file for bankruptcy if your wages are about to be garnished, you're facing repossession or foreclosure, or you can no longer afford to make the payment," said Matt. "You should also file if you have more than \$10,000 of unsecured debt that you can't realistically pay off, facing an IRS collection or if the Department of Education is coming after you for student loans."

One myth about bankruptcies is that it will ruin someone's credit

"Bankruptcy does not kill credit because your credit is already tanked. Not making the payments is not going to make your situation any worse," Matt said. "Most people still have an income, and they can get secured credit cards. Most secured credit cards require at least \$300 on them and must

be paid in full. You can use it to buy groceries, gas, and car repairs. They can help to re-establish credit."

Emily: Yes, I live in Lakewood and Lakewood has been perfect.




