A Big Thank You To Lakewood From Supplies4Success

Here we are celebrating the end of another school year which of course includes celebrating the generosity of our Lakewood community.

For the past decade Supplies4Success has run a summertime city-wide school supply drive supporting our K-12 grad students. There are several collection methods: local businesses and churches act as collection sites where

people can drop off items throughout the summer, H2O campers recycle gently use items, and you can even donate funds directly for purchasing and leave the shopping to us!

Once items have been collected, a group of volunteers get together to sort, count, and box up the supplies for delivery in time for the start of school. Items are available at every building, and there are no financial requirements for students to access these supplies.

The committee wanted to report some exciting numbers from last summer's collection. In 2023 we collected over 16,000 items to create supply closets in each of our schools. This number includes 5,000+ pencils, 2,500+ pens, 1,400+ folders, and so much more. If you want to know more about the impact of these stocked supply closets in each building, take it from our teachers: "Harrison Elementary School embraces diversity and inclusion and strives to create a warm and supportive environment for all our students including many new immigrants and refugees. Students can "shop" for backpacks, lunch bags, and other needed supplies. Equipping new Harrison students in need with school supplies fosters a sense of belonging, promotes academic engagement, alleviates a financial burden on their families. We are so grateful for the donations. Recently we welcomed a new student to Harrison, and he was able to pick out a brand-new Spiderman backpack. His eyes widened in excitement like he couldn't believe it was real!"--Tiffany Hickey & Jeannette Sgambellone. We hear stories like this each year from all of our buildings. The 411 On 420 In 44017

Hi Neighbors! Cheeky headlines aside, I know many folks have been wondering about adult-use, or recreational cannabis sales in Lakewood, so I thought I'd...uh...clear the air.

The short answer is that the City of Lakewood is ready for business!

June 3rd – Lakewood City Council passed Ordinance 42-2023 which allows for the permitting of adult-use dispensaries.

June 6th – Lakewood's citizen-led Planning Commission heard the first two applications for mixed-use distribution from the two current medical marijuana dispensaries.

June 7th – the State of Ohio's Division of Cannabis Control (DCC) began accepting applications for mixed-use licenses.

September 7th – deadline for the DCC to issue provisional licenses. All Ohio adult-use dispensaries must have a license from the DCC to operate legally.

You may recall hearing about a temporary moratorium on adultuse dispensary licenses in Lakewood. You may also recall that immediately after Issue 2's passage, Republicans at the Statehouse introduced two bills to repeal or drastically alter the law.



Unlike Issue 1 which placed language into the Charter, Issue 2 placed Chapter 3780 into the Ohio Revised Code, which state legislators can amend at any time through the legislative process. Additionally, Chapter 3780 created the State of Ohio Division of Cannabis Control (DCC) and gave them until August 7th to create the rules, regulations, and safeguards necessary to license adult-use marijuana dispensaries, processors, and cultivators. Lakewood passed our temporary moratorium to express our intention to wait to begin local permits until July or the finalization of DCC regulations, whichever came first.

To make sure that we would be

ready as soon as the state would allow, in December 2023, now Vice President Jason Shachner and I introduced a package of legislation with a majority of our colleagues to update our criminal code, zoning and potential

licensing. We have been diligently collaborating with the administration ever since to make sure that we could be ready for this moment and to respond to the 80% of Lakewood voters who supported Issue 2.

In May, after months of work, Lakewood City Council passed Ordinance 40-2023 "de-criminalizing" possession in alignment with Chapter 3780 while also clarifying our local expectations to keep consumption out of public settings such as parks, sidewalks and restaurant patios. In June, we passed the above-mentioned Ordinance 42-2023, repealing the moratorium and establishing permitting of adult-use.

So there you have it folks. Lakewood is once again leading the way and is positioned to be one of the first northeast Ohio suburbs ready to welcome adult-use sales. Our neighbors will be green with envy.

THE MAYOR'S CORNER

Taking Care Of Our Buildings

Lakewood's status as both a charming, historic place and as Ohio's most densely populated city helps make our community unique and full of activity. Over 50,000 people call Lakewood's 6.7 square miles home, with more than 32,000 housing units (most of which were built before World War II). At City Hall, we are laser-focused on ensuring that buildings in Lakewood remain safe, especially with so many people living in and visiting our city, and considering the age of structures. With all this in mind, the work of our Division of Building and Housing is crucial to the quality of life in Lakewood.

Lakewood's building and housing team, led by Commissioner Chris Parmelee, has a lot on their plate. A given year finds them overseeing a wide range of work on residential and commercial buildings and even food trucks. Our team of inspectors regularly reviews the condition of buildings across Lakewood and guides those looking to make repairs, alterations, or new builds.

Last year alone, our inspectors reviewed and issued over 2,700 building permits – these can include anything from the simple installation of a new water heater to the construction of an entirely new building. Building and Housing also oversees the annual licensing for owners of rental housing, which involves over 3,200 landlords. This work on rental units also includes a full interior inspection every time title changes hands on an individual unit.

For all single and two-family homes (whether rental or owner-occupied), the City performs an exterior inspection on a triennial basis. Our inspectors use a four-point scale, with a "1" finding no exterior code vioby Meghan George

lations and a 4 finding "significant disrepair" with multiple major violations. Recently, we realized that we needed a similar level of regular review of Lakewood's commercial buildings and worked to build new policies.

To this end, we introduced three new tools. First, beginning in 2023, we now perform exterior surveys of Lakewood's 1,500 commercial structures. Second, for buildings over four stories tall and more than 30 years old and for parking structures, the City now requires owners to secure a structural engineer to regularly issue an expert report on building

safety and overall condition. Finally, this year Lakewood will begin implementing its automotive business registration program to address the unique factors present in these commercial properties. (As noted, Building and Housing already oversees the City's food truck registration process).

As you can see, our Building and Housing team and our policies are highly proactive in working to prevent problems with Lakewood buildings. However, our inspector also will respond quickly when we receive a complaint from the public. If violations are

discovered, we always attempt to work with property owners to find solutions and connect people to tools and resources to address matters. The City also recently re-introduced the Heritage Home Program, which provides access to professional guidance and low-cost, below-market-rate financing.

There is an immense volume of work ongoing to keep Lakewood's buildings in safe condition. The City and our residents are fortunate to have an excellent team looking out for all of us in the Division of Building and Housing and helping ensure that we all keep Lakewood's buildings in top condition.

CITY COUNCIL OBSERVED

Angela Byington, Lakewood's New Director Of Planning And Development

City Council met on Monday, June 17th after meetings of the Finance Committee and the Committee of the Whole.

Angela Byington was introduced to the Committee of the Whole where they were able to ask questions before recommending her to the full council to confirm her as Mayor George's selection for new Director of Planning & Development. She was later confirmed and sworn in at the council meeting.

Byington expressed excitement about working in a more "urban" community than Perkins, Ohio where she had been employed previously. She described Lakewood as "Vibrant, unique and progressive." She addressed the fact

that Lakewood has combined the Planning and Development roles which is not how the majority of cities are organized. She has held a similar position elsewhere and has previous experience in Sandusky and Lorain as well.

The Finance Committee meeting was 9 minutes long.

The highlight of the evening was during the council meeting when Councilman Baker's "Complete Streets" legislation was introduced. It is co-sponsored by multiple members of council and was vocally supported by six members of the community. The proposed ordinance would create a public forum for any and all changes made to roads, sidewalks, bike lanes and other infrastructure.

Mayor George spoke sharply and passionately about how the city employs many trained professionals in these areas and that they should be entrusted with these decisions. Councilpeople Schachner and Baker responded by stating that they do not believe the current wording of the ordinance hampers the administration's ability to make recommendations and decisions.

I thought the Committee of the Whole might address the vacant lot at the corner of Belle and Detroit but I guess that would fall to the Committee of the Hole.

There were about 15 members of the community in attendance.

Observations On The District:

The Good, The Better And The What The Heck: Part 4

According to policy 0165.2 The Board can call a special meeting. "A special meeting of the Board may be called by the Board President, Treasurer, or by any two (2) Board members" It gives "at least twenty-four (24) hours advance notice to the news media that have requested notification, except in the event of an emergency requiring immediate official action." "Special meetings of the Board shall be public. R.C. 121.22" Notification of a special meeting is posted on the LCSD website on the calendar and you can sign-up to get notifications by emailing kent.zemen@lakewoodcityschools.org or calling 216-529-4096. Notifications must be posted at least 24 hrs before the meeting time.

Summer break is here and now our community turns to the extraordinary Recreation Dept. headed by Leslie Krogman. Baseball, softball and the outdoor Lakewood pools. Youth and adult sports, and so many more choices like CSI for ages 7-11, chess lessons K-8, virtual handyman skills for adults and so much more. https://tinyurl.com/ mryh9hrw Hundreds of participants and volunteers keep the Lakewood traditions alive and create incredible summers to remember. Don't forget the other summer traditions of the July 4th parade in the morning and The Lakewood Project concert at night leading into the best fireworks show in northern Ohio.

What the heck:

On February 29, 2024 the board held a special meeting. The agenda was "Planning Session." Going to minutes for a bit more detail: "The Superintendent and Cabinet members provided Board members with an update on matters pertaining to the 2023-2024 school year and discussed planning for the 2024-2025 school year and beyond." There was no video or audio recording of this meeting. I would have

absolutely attended this meeting but at the time did not know the procedure of signing up to be informed that one was being held. But I do think this is a huge discussion that stakeholders should have been involved with and should have been in a general meeting and recorded. When the board does this type of thing, we can only assume that the transparency has left the building. The board is supposed to serve the stakeholders. All of the employees of LCSD are also supposed to serve the stakeholders and taxpayers of Lakewood. Somehow this has been turned upside down and sideways.

Role of "public servant": At its core, the term "public servant" denotes an individual whose primary motivation and role are to serve the interests, needs, and well-being of the public.

Definition of "volunteer": A person who freely offers to take part in an enterprise or undertake a task.

Policy 8120 introduces the topic of LCSD volunteering. "The Superintendent shall be responsible for recruiting community volunteers, reviewing their capabilities, and making appropriate placements." I recently volunteered with the Lakewood Project concert, a group I co-founded and for which I am the director in charge of technology. These are some rules shared with my team as we prepared and worked with the students: "In the role as a volunteer... please bring your concerns to the staff member in charge of your event and allow them to determine what should go to who." --Dr. Palumbo. This rule applies when a volunteer is actively at an event also. So, volunteers listen up, take time to find that staff member or you will not be able to send any communications to other staff members that may also be involved. Also, that designated staff member is the only person that can communicate with LCSD staff members during the event you volunteered for.

Furthermore, volunteers will not dictate times or need for meetings. So, if a volunteer needs to meet with

a staff member and the availability is while you are at work, just take the time off and wait until the staff member approves of the meetings' need and sets a time at the staff members' convenience.

According to Superintendent Niedzwiecki, "Volunteers do not direct employees." Somehow the staff member is to psychically determine the needs of the volunteers' event or just decide on their own what the volunteer needs. The superintendent continues: "As the Civic manager, you would never have allowed volunteers to direct you." This could not be further from the truth. It was my job as an employee of LCSD and the Civic manager to take direction from volunteers from the PTA, Music Boosters and Athletic Boosters to name a few. It was my job to make all events successful and that meant taking direction from many people and helping their events to be what they wanted them to be.

I had emails from and in-person meetings with the superintendent and assistant superintendent as we prepared for our concert. After everything was done, I did ask for some sort of directions for being a good volunteer in order to not step on the landmines that apparently, I kept stepping on. There is no such document. Super-

intendent Niedzwiecki responded to my request for the guidelines with an email: "There are no specific guidelines for volunteers. Volunteers are just that: volunteers. They are here to assist employees, specifically the employee who has them as a volunteer." I think of some of the other volunteer groups that must follow these guidelines: PTA, Athletic Boosters, Music Boosters, the many, many parent coaches for our Recreation Dept teams, who all need to make sure they don't break the 3 rules I know of, and all the other guidelines that aren't available, to have a good and successful experience when volunteering for LCSD.

My life isn't any better today because I completed those tasks, and the car wash will never reopen.

It's hard to remember exactly what the proprietor looked like. Overalls, random hats (I guess a cowboy, firefighter, or pirate could operate a car wash?), always something in his mouth.

I still see the proprietor every day. He is doing fantastic, looks great... and is about to graduate High School. (Gulp)

The car wash's colorful walls have faded. The few cars left are not clean. Once we realized it would never have a new owner, we retired it to a donation box by our front door. Never took that final ride to the donation center, though. Only clothes, books, and toys with lesser emotional attachment. We have walked past that particular donation box for years. Good days (Little

League championship...), bad days (appendicitis...). Dressed up and leaving to say goodbye to Grandparents, then returning with a piece of our hearts missing.

The long-dreaded day arrived last week: High School is finished. (Gulp) Absolutely heartbroken amidst all his bliss, I decided today was the day. Waited for the garbage truck. Closed my eyes. Tossed it in. Meanwhile, he bounded into the house and excitedly purged his backpacks, gathering all the materials he would no longer need. Ran past me as I was trudging back into the house, caught the garbage truck, and gleefully threw it all in. Thereby burying the abandoned car wash.

I am looking at a photo of the Proprietor and his Car Wash in all their glory. I brace myself as I flip it over... 15 years ago?! Such a long- yet fast- imperceptible disappearing act: car washes, train tracks, party favors, building sets, mispronunciations, 20-pound-last-dayof-the-quarter-backpacks, gratuitous band-aids, hand-made presents, inevitably monochromatic Play-Doh sets, all things Nerf, a lowered backboard... rain boots with a 50% chance of being on the correct feet!

I have searched high and low, and now sadly conclude that there is not one single crayon in this house.

I can't see "Bracken Park" -- the Whiffle Ball Stadium in our backyard-- anymore.

Lastly: that little hand will never again hold on tight to mine as we head off on our adventures. (No future adventures will involve hand-holding.)

In the May 8th issue Tristan Rader wrote an article describing some of the duties and responsibilities of our state legislators. He listed quite a few responsibilities including climate change, worker's rights, marijuana legislation etc. However, he failed to mention that our state representatives have direct control over our real estate property taxes in Ohio.

Even though we pay our property taxes to Cuyahoga County, the methods and formulas for those taxes are controlled by our elected officials in Columbus. Very few politicians want to discuss lowering our property taxes for one main reason. In most counties, 65-75% of our property tax goes to fund public schools. Most politicians are deathly afraid to upset the school teachers unions who are huge supporters and contributors to their campaigns.

The sad reality is that every three years our home evaluations increase and the public schools receive an automatic increase in funding that has not be voted on by the taxpayers. Because of this taxing formula, seniors are being driven out of their homes. Property values are going through the roof and while it may be a windfall for those individuals selling their homes, it is an incredible burden to the rest of us.

Many of us seniors want to stay in the homes where we raised our families and have resided for many years. The increase of value in our homes will not be realized until we sell. In the meantime, the pressure from rising costs in food, fuel and medical care combined with high property taxes is devastating.

JOIN THE MOVEMENT! - Citizens for Property Tax Reform is attempting to rally seniors in Cuyahoga County to put pressure on our politicians to make changes in the property tax structure.

In Phase 1, we are asking for immediate relief for seniors by putting a freeze on current property taxes for everyone 65 years or older and increasing the eligibility for the Homestead Exemption. How To Safely And Legally Navigate Bike Lanes

About those bike lines you're increasingly seeing around Lakewood and the Greater Cleveland area...many communities have added bike lanes to their roadways for the specific, exclusive use of cyclists. Some are "protected" with bollards (as on the stretch of road between Clifton and Lake Roads connecting Lakewood and Rocky River), some are simply painted stripes and a bike image with a directional arrow on the pavement.

Cyclists have the right of way when riding in a bike lane, and motor vehicles cannot travel in them. However, if the lane is clear of cyclists, a motorist may cross a bike lane to make a turn, access parking, or enter or exit a roadway.

No vehicle, except for a bicycle, can stand or be parked in a bike lane or

in any way impede bike traffic.

When there is a bike lane present, a cyclist may still choose to ride on the road, "taking the lane." Adult cyclists have a legal right to ride on the road in Ohio (except on divided, controlled access freeways).

She accumulated over 100 hours of community service as her way of giving back to a community that supported her family in their adjustment to this country.

Mimi served four years on Lakewood's Student Council and was active in LHS's Help 2 Others program. She was recognized for her sportsmanship in volleyball and lacrosse. She will attend The Ohio State University to study health sciences, aiming to become a physician's assistant.

Leah Campbell is an accomplished woodwind player for Lakewood High School and the Cleveland Youth Wind Symphony. She ran cross-country and track, volunteered with the Help 2 Others program, and was co-president of the History Club, expanding its reach beyond the school to the Lakewood Public Library.

The scholarship interview team was impressed by her work in a program called "Trout in the Classroom" that raised baby Rainbow trout at school, then released 118 of them into the Rocky River. She received the Gold Award from the Girl Scouts because of the recycling program she initiated at

She is also a volunteer peer coach, supporting families affected by substance use disorders. Her dedication to community involvement and her advocacy for understanding and kindness reflect her belief in the power of collective action and conversation. For almost two years, Chitra has worked part-time as a community resource specialist in the City of Lakewood's Lakewood Area Collaborative, Division of Youth and will be retiring at the end of this month.

Chitra was instrumental in bring-



ing the ME/WE Family Education Program and Support Group to the City of Lakewood. The group meets, both in-person and virtually on Saturday mornings from 10am-12pm at The Cove Community Center. This unique program provides education and support for families concerned about a loved one's substance use, offering a 12-week cycle covering 10 different topics and peer support. Funded by the Opioid Settlement, it helps families understand addiction, set healthy boundaries, and prioritize self-care.


