3. TERM

The Term of this Pricing Schedule will expire thirty-six (36) months from the Acceptance Date.

4. SERVICE DESCRIPTION

The Service(s) to be provided by AT&T are: (1) PremierSERVSM Frame Relay Service ("FRS" or "Service"), a transport service that facilitates the exchange of customer data in variable length information units, frames or packets between end-user connections by way of assigned virtual connections; and/or (2) PremierSERVSM Asynchronous Transfer Mode ("ATM" or "Service"), a broadband communication technology using cells capable of carrying a wide range of services.

5. SERVICE LOCATION, INSTALLATION AND ACCEPTANCE

- A. AT&T will provide Service to Customer at the location(s) listed on Exhibit 1 hereto.
- B. AT&T will provide Customer with an installation date for the Service. If AT&T determines that the scope of the work involved requires special coordination, then an AT&T project manager will be assigned.
- C. AT&T shall perform standard tests at each location. Acceptance of the Service by Customer at a location ("Acceptance Date") will be deemed made immediately following successful completion of these tests for such location.

6. PRICES AND QUANTITIES

- A. Prices for Service are listed in Exhibit 1 hereto. The charges will commence on the date Service is made available by AT&T. If Customer is not ready for the Service on the date that AT&T notifies Customer that it is ready to make the service available, then the AT&T billing cycle will commence at the same time as billing from AT&T's vendors commences.
- B. ***All rates are contingent upon AT&T's performance of a facility check prior to installation of Service. If the facility check reveals the need for special construction, AT&T will notify Customer that special construction is required. Special construction requires an additional special construction charge, which must be paid by Customer prior to AT&T or its vendor(s) commencing the special construction. Expedite charges, Service Order Change Charges or other special charges are also in addition to stated rates.***

7. REGULATORY

AT&T and the Services may be regulated by certain rules, regulations and orders of state or federal regulatory agencies or may be subject to certain requirements set forth in law, statute or ordinance. If this Pricing Schedule/Service Agreement, or (if applicable) a Guidebook, Service Guide, Business Service Agreement, and/or Master Agreement, or any part thereof, is subsequently deemed, or AT&T, in good faith, at its sole discretion, believes it may be deemed, to conflict with any of the above, then AT&T may, to that extent, modify or terminate the affected document without liability.
