Nature of Contract: (Briefly describe the general terms of the contract)

This agreement with the California Department of Food and Agriculture (State) provides \$11,114 in reimbursement and requires the County Department of Agriculture/Weights and Measures (County) to inspect 752.50 acres of nursery stock, enforce licensing requirements and enforce levels of pest cleanliness. In addition, under this agreement, the County will be paid \$75 for each new nursery license issued and \$75 for each renewed forfeited (delinquent) license secured by the County. Finally, the County will receive an hourly rate, not to exceed \$35 per hour, for nursery investigative work, provided such investigative work is approved in advance by the State.
