FIRST AMENDMENT TO MASTER ASSIGNMENT AGREEMENT

THIS FIRST AMENDMENT TO MASTER ASSIGNMENT AGREEMENT, dated as of July 1, 2009, is by and between the INLAND EMPIRE PUBLIC FACILITIES CORPORATION, a nonprofit, public benefit corporation organized and existing under and by virtue of the laws of the State of California (the "Corporation"), and WELLS FARGO BANK, NATIONAL ASSOCIATION, a national banking association organized and existing under the laws of the United States of America, as successor to Texas Commerce Bank National Association, as trustee (the "Trustee"), amending that certain Master Assignment Agreement, dated as of February 1, 1994, recorded on March 1, 1994, as document number 94-101403, in the Official Records of San Bernardino County, California, as amended by that certain First Amendment to Master Assignment Agreement, dated as of June 1, 1995, by and between the Corporation and the Trustee, and recorded on June 27, 1995, as document number 19950219550, in the Official Records of San Bernardino County, California, (collectively, the "Assignment Agreement");

WITNESSETH:

WHEREAS, San Bernardino County, California (the "County") and the Corporation have heretofore entered into that certain Master Site Lease, dated as of February 1, 1994, recorded on March 1, 1994, as document number 94-101401, in the Official Records of San Bernardino County, California, as amended by that certain First Amendment to Master Site Lease, dated as of June 1, 1995, by and between the Corporation and the County, and recorded on June 27, 1995, as document number 19950219578, in the Official Records of San Bernardino County, California, and as amended by that certain Second Amendment to Master Site Lease, dated as of July 1, 2009, by and between the Corporation and the County, and recorded concurrently herewith (collectively, the "Site Lease"), pursuant to which the County leased certain real property, described in Exhibits A and B thereto (the "Property") to the Corporation and the Corporation leased the Property from the County;

WHEREAS, the Corporation and the County have heretofore entered into that certain Master Lease Agreement, dated as of February 1, 1994, by and between the Corporation and the County, and recorded by memorandum on March 1, 1994, as document number 94-101402, in the Official Records of San Bernardino County, California, as amended by that certain First Amendment to Master Lease Agreement, dated as of June 1, 1995, by and between the Corporation and the County, and recorded on June 27, 1995, as document number 19950219579, in the Official Records of San Bernardino County, California, as supplemented by that certain unrecorded First Supplement to Master Lease Agreement, dated as of June 1, 1995, by and between the Corporation and the County, as supplemented by that certain unrecorded Second Supplement to Master Lease Agreement, dated as of January 1, 1996, by and between the Corporation and the County, as supplemented by that certain unrecorded Third Supplement to Master Lease Agreement, dated as of September 1, 1997, by and between the Corporation and the County, as supplemented by that certain Fourth Supplement to Master Lease Agreement, dated as of October 1, 1998, by and between the Corporation and the County, and recorded on October 22, 1998, as document number 19980449438, in the Official Records of San Bernardino County, California, and as amended by that certain Second Amendment to Master Lease Agreement, dated as of July 1, 2009, by and between the Corporation and the County, and recorded concurrently herewith (collectively, the "Lease Agreement"), pursuant to which the Corporation leased the Site and certain improvements thereon (the "Property") to the County and the County leased the Property from the Corporation;

WHEREAS, the Corporation and the Trustee have heretofore entered into the Assignment Agreement pursuant to which the Corporation assigned to the Trustee its right to receive lease payments made by the County under the Lease Agreement (the "Lease Payments");

WHEREAS, the County, the Corporation and the Trustee have heretofore entered into that certain unrecorded Trust Agreement, dated as of February 1, 1994 (the "Trust Agreement"), pursuant to which, among other things, the Trustee executed and delivered certificates of participation representing direct, undivided fractional interests in the Lease Payments (the "Certificates");

WHEREAS, the County has determined that it is necessary to amend the description of the Site, as set forth in the Site Lease, the Lease Agreement and the Assignment Agreement to release a portion of the real property described therein;

WHEREAS, the County and the Corporation and the Trustee deem it necessary and desirable that the Site Lease be amended to provide for a revised description of the Property to accurately reflect the description intended to be included therein following such release;

WHEREAS, Section 8.3(c) of the Lease Agreement grants to the County the option to release any portion of the Site, provided that the County shall satisfy certain requirements which are conditions precedent to such release;

WHEREAS, the County has satisfied all such requirements;

WHEREAS, Section 10.01 of the Trust Agreement provides that the Lease Agreement and the rights and obligations of the respective parties thereto may be modified or amended at any time by a supplemental agreement, without the consent of any Owners, but only to the extent permitted by law, among other things, to cure, correct or supplement any ambiguous or defective provision contained therein and which shall not, in the opinion of nationally recognized bond counsel, materially adversely affect the interests of the Owners of the Certificates, and in regard to questions arising thereunder as the parties thereto may deem necessary or desirable and which shall not, in the opinion of nationally recognized bond counsel, materially adversely affect the interests of the Owners of the Certificates;

WHEREAS, the County and the Corporation have received an opinion of nationally recognized bond counsel providing such required opinions;

WHEREAS, the Trust Agreement also requires that any amendment to the Lease Agreement requires the prior written content of MBIA Insurance Corporation, as municipal bond insurer of a portion of the Certificates; and

WHEREAS, the County has received written content from MBIA Insurance Corporation to the amendments;

NOW, THEREFORE, in consideration of the above premises and of the mutual covenants hereinafter contained and for other good and valuable consideration, the parties hereto agree as follows:

SECTION 1. Amendment of the Assignment Agreement.

(a) The existing description of the Property contained in Exhibits A and B to the Assignment Agreement is set forth in Exhibit A attached hereto.

- (b) The Property is hereby amended by excluding certain of the property described in Parcel I thereof, as shown in Exhibit B attached hereto.
- (c) The resulting description of the Property shall be as described in Exhibit C attached hereto.
- SECTION 2. <u>Execution in Counterparts</u>. This First Amendment to Master Assignment Agreement may be executed in several counterparts, each of which shall be an original and all of which shall constitute but one and the same instrument.
- SECTION 3. <u>Applicable Law</u>. This First Amendment to Master Assignment Agreement shall be governed by and construed in accordance with the laws of the State of California.
