Nature of Contract: *(Briefly describe the general terms of the contract)*

This agreement with the California Department of Food and Agriculture (State) provides \$11,597 in reimbursement and requires the County Department of Agriculture/Weights and Measures (County) to inspect 834.94 acres of nursery stock, enforce licensing requirements and enforce levels of pest cleanliness. In addition, under this agreement, the County will be paid \$50 for each new nursery license issued and \$50 for each renewed forfeited (delinquent) license secured by the County. Finally, the County will receive an hourly rate, not to exceed \$35 per hour, for nursery investigative work, provided such investigative work is approved in advance by the State.
