**FIRST AMENDMENT TO THE CONTRACT
BETWEEN THE COUNTY OF SAN BERNARDINO
AND FAMILY SERVICE ASSOCIATION OF REDLANDS
(CONTRACT NO. 09-902 A-1)**

This First Amendment to Contract No. 09-902, hereinafter referred to as "AMENDMENT," is made and entered into by and between the COUNTY OF SAN BERNARDINO, hereinafter referred to as "COUNTY," and FAMILY SERVICE ASSOCIATION OF REDLANDS, hereinafter referred to as "FAMILY SERVICE ASSOCIATION OF REDLANDS."

FAMILY SERVICE ASSOCIATION OF REDLANDS is considered to be a service provider, providing services for the County's Homelessness Prevention and Rapid Re-Housing Program (HPRP) grant, Catalogue of Federal Domestic Assistance (CFDA) No. 14.258.

WHEREAS, COUNTY and FAMILY SERVICE ASSOCIATION OF REDLANDS previously entered into Contract No. 09-902 on September 22, 2009, in the amount of \$342,450 and hereinafter referred to as "CONTRACT," to allow FAMILY SERVICE ASSOCIATION OF REDLANDS to utilize HPRP funds for the provision of homeless prevention and stabilization activities; and,

WHEREAS, the HPRP grant includes \$152,020, up to five percent (5%) allocation, for administration of the grant; and,

WHEREAS, COUNTY is required to share the administration allocation with selected service providers; and,

WHEREAS, COUNTY and FAMILY SERVICE ASSOCIATION OF REDLANDS desire to amend CONTRACT to obligate additional funds to the HPRP.

NOW, THEREFORE, in consideration of the mutual covenants herein set forth and the mutual benefits to be derived therefrom, the parties agree as follows:
