SUBJECT: ESTABLISH SPEED ZONE ON DOS PALMAS ROAD, VICTORVILLE AREA

RECOMMENDATION(S)

Adopt a **Resolution No. 2008-254** to establish 40 M.P.H. speed zone on Dos Palmas Road, in the Victorville area, pursuant to County Code Section 52.0123(a).

BACKGROUND INFORMATION

Subsequent to a request from a local resident, the Department of Public Works conducted an engineering and traffic survey on Dos Palmas Road, in the Victorville area. The radar speed survey conducted by the Department revealed the majority of motorists traveling at the approximate speed of 40 M.P.H. The present speed is unposted 55 miles per hour. It was subsequently determined that the lower speed limit is safer and more reasonable for Dos Palmas Road. Therefore, in the interest of public safety, the Department recommends establishment of a 40 M.P.H. speed zone on Dos Palmas Road, in the Victorville area, per County Code Section 52.0123(a). Approval of this action will authorize the Department to install the appropriate speed zone signs at the subject location.

FINANCIAL IMPACT

There will be a cost incurred of approximately \$2,400 to install the appropriate signs, as well as minor administrative costs to update Department records. Funds for this action are available in the Department's 2008/09 Operations budget.
