## November Election, School Master Plan And Beyond

Once again, I want to encourage everyone to vote this election. I ask that you join me in voting "YES" on Issue 12. Issue 12 is a no tax increase renewal of two existing Parma City School District operating levies. This issue is completely unrelated to the FOUR failed bond issues related to new construction. Operating levies are how we pay for the day-to-day activities at our schools such as teachers, student curriculum, and support staff. Regardless of any differences on the direction of this district or who one may or may not support for school board the only responsible vote for issue 12 is "Yes".

Next, I'm going to set the record straight. Since my last article Char Eastin Rossi, administrator of the Parma Senior Alumni Facebook Group wrote that I "spoke without the facts...they found out that Charlie was right but they don't apologize now do they?" Nothing can be further from the truth. I immediately reached out to Ms. Rossi asking for explanation and/or to meet to discuss the facts and have not heard back in two weeks. In August I brought new facts to everyone's attention, and I stand by each item as 100% factual.

Based on this information, I asked the School Board for an immediate halt to liquidation and demolition so that all options available are made public and open for debate before irreversible events occur.

#### That information was:

1) The Parma City Schools could have qualified for 100% of the funding they sought from the OFCC without tearing down more schools.

2) In the event that the waiver is not approved, it is not unlawful or against any rules or OFCC guidelines for the school

# The Representative's Corner

Back in 2018, when I was serving as President of Parma City Council, a tragedy struck the community. Police Chief Joseph Bobak informed me that a little boy who obtained his father's handgun accidentally killed himself. Needless to say, like many, I was very saddened by the incident and the councilman, school teacher, and father in me wanted to prevent this type of calamity from happening again on my watch.

As a result, I worked with Parma Law Director Timothy Dobeck and Ward 5 Councilman Allan Divis to design a free gun lock program. Since that time, we have worked with the National Sports Shooting Foundation's (NSSF) Project Child Safe program and the Parma Police Department to give away nearly 2,000 gun locks to residents.

Ever since joining the Ohio General Assembly in January, I have worked hard to seek ways to bring folks on both sides of various issues together. I am very happy to say that I have experienced much success, as most of the bills that I am working on are bipartisan in nature. I am especially proud of House Bill 186 (HB 186), which I introduced with Representative Darnell Brewer of Cleveland. HB 186 would exempt firearm safety devices, such as gun locks and safes, from sales tax. Many tell me that the bill is historic in the sense that it has brought folks on both sides of the



gun debate together. In fact, gun control groups such as Moms Demand Action, Sandy Hook Promise, and Every Town for Gun Safety and gun advocacy groups like the National Rifle Association, the NSSF, and the Buckeye Firearms Association support our bill.

Our proposal addresses a critical aspect of public safety, responsible gun ownership, and the well-being of our communities. By making gun safety devices more affordable, we remove financial barriers for gun owners to secure their firearms properly. We know it will not solve every tragedy and we are not discussing the merits of gun ownership or gun policies. Instead, we are focusing on a common-

sense approach to incentivize firearms owners to do so responsibly and safely, like I have since I obtained my first gun when I was a young man growing up on my grandma's farm.

Studies have consistently shown that gun safety devices, such as gun safes, trigger locks, and biometric access systems, play a crucial role in preventing accidental discharge, unauthorized access to firearms, and gun thefts. They provide a layer of security that can help keep firearms out of the wrong hands, particularly when it comes to protect-

In the budget that passed in July, House Bill 33, we were able to achieve:


- · Increased funding for infant vitality and health

# **Civil War Nurse And - Founder Of The American Red Cross**



- \* Clara Barton was born Decemeber 25th, 1821, in Oxford Massachusetts
- \* She Distributed Medical Supplies to Civil War Battlefields
  - \* Founded the American Red Cross
- \* Died on April 12, 1912 in Glen Echo, Maryland

When the Civil War began Clara Barton was working as a clerk in the U.S. Patent Office. She learned that the Union Army was short of Medical Supplies, so she immediately set up an agency to fill the need. Although she was told the battlefield was no place for a woman, she gained permission to go to the front lines. At one battle after another she distributed supplies, nursed the wounded, and searched for men listed as missing. To the soldiers, she became known as "The Angel of the battlefield".

After the war, she went to Europe for a rest. Soon, though, she became involved as a Nurse in a War there, She learned about the work of the newly formed International Red Cross and returned home determined to establish an American Chapter.

After a ten year struggle, the Amereican National Red Cross was established in 1881, with Barton as its first President. She also wrote the American Amendment to the Geneva




Convention, which was an international agreement that gave the Red Cross the authority to provide help in time of any disaster, such as floods or earthquakes, rather than only in wartime.

It's important to note that Clara Barton was a very INDEPENDENT Woman. Barton caused crticism of the Red Cross when she appeared on the battlefield in Cuba during the Spainish-American War (1898). Some people said that she should not have been there as she was 77 years old. Her insistance on doing things her way led to the request that she step down as Red Cross President in 1904.

It is my opinion that if it were not for Clara's INDEPENDENT nature, the American Red Cross may not have been adopted. Thank God for Clara Barton and Women and Men like her.

## **Thank A Veteran On Veterans Day**

On Saturday November 11th we celebrate Veterans Day as a recognition and tribute to all service men and women who have sacrificed so much, were willing to, or have given their lives to defend our country. The difference between Memorial Day and Veterans Day is that Memorial Day is a somber day in which we honor and pay tribute to those servicemen and women who gave their lives in the defense of our country, on Veterans Day we celebrate and honor "all" Veterans past and present. This is a day that we must also remember and honor the families of the men and women who served and especially the Gold Star families that has lost an immediate family member in the line of duty of military service.

Veterans Day was originally called "Armistice Day." Originally on November 11, 1919, it was the first anniversary of the end of World War I and was originally established to honor veterans of World War I, but now it extends to all veterans. The first celebration using the term Veterans Day occurred in Birmingham, Alabama, in 1947. Raymond Weeks, a World War II veteran, organized "National Veterans Day," which included a parade and other festivities, to honor all veterans. The event was held on November 11, then designated Armistice Day. Later, U.S. Representative Edward Rees of Kansas proposed a bill that would change Armistice Day to Veterans Day. In 1954, Congress passed the bill that President Eisenhower signed proclaiming November 11 as Veterans Day.

In 1968, the Uniform Holidays Bill was passed by Congress, which moved the celebration of Veterans Day to the fourth Monday in October. The law went into effect in 1971, but in 1975

President Ford returned Veterans Day to November 11, due to the important historical significance of the date. Every year on Veterans Day, at exactly 11 a.m., a wreath-laying ceremony is held at the Tomb of the Unknowns in Arlington National Cemetery.

According to the Department of Veterans Affairs, there are over twentythree million war veterans living in the United States. Veterans over the age of sixty-five number 9.2 million, while 1.9 million are under the age of thirty-five, Female veterans' number 1.8 million, those who served during the Vietnam War era (1964-1975) number 7.8 million, which is 33 percent of all living veterans. Veterans who served during the Gulf War (standing for service from Aug. 2, 1990, to present) number 5.2 million. Veterans who served during World War II (1941-1945) number 2.6 million. Veterans who served during the Korean War (1950-1953) number 2.8 million. Six million veterans served in peacetime.

Veterans Day is all about honoring those who served. If you see one, thank one. They probably don't hear it enough, and Veterans Day is the perfect opportunity to express your gratitude

## Self-Defense-Prepare For Danger

It is one thing to see crime stories plastered across the news headlines, and another one to be a part of those headlines. Nobody wants that! But how do you prepare yourself for a potentially dangerous situation? It's usually not the first thing on a person's mind. Although, most people do prepare for other unseen circumstances or disasters by purchasing insurance. But how do you maintain your personal safety? Financially speaking, there is no, "personal safety insurance" to purchase. Sure, you could hire bodyguards, but realistically this is impossible for a huge percent of the population.

Usually when the subject of personal safety is raised, the first thought is that of guns. The second is mace which is the first weapon that is normally associated with a women's safety. But weapons are not dependable. And if you are thinking that you have a definite plan to use them, then think again. Weapons can fail. Guns can jam and mace can be aimed in the wrong direction. And obviously, if the assailant is using a gun to threaten you, the time is gone to pull yours.

Preparing for danger is more than just "thinking" of what you will do. It means preparing yourself mentally and physically. Self-defense is more of a mental process than a physical

one. Since fear interrupts your thinking processes, you must try to focus the fear into an effective response. One way to help accomplish this is to participate in a self-defense course. Self-defense classes not only helps you prepare physically, but they also enhance your mental abilities and your state of awareness. These are important to your well-being, whether you are carrying a weapon or not. In the instance when you are caught off guard, your first response must be a lifesaving response. Will you be ready if someone grabs your shoulder, or a gun is pointed in your face or to the side of your head? Preparing for these types of situations takes mental preparation. Where do you start? You are the only one who can decide what measures to take. The best place to begin is with a defense plan. Practice the plan until it becomes routine. Then change that routine. This means having a backup plan in place. A backup plan is needed in case the original plan fails. It must follow quickly since there will be no time for you to think of what to do next! With this in mind you must remember that no matter what safety measures you decide to take, don't forget to add a backup plan! What's yours?

I have listed some helpful tips to remember when faced with an attacker: Remain calm Don't show your fear You have approximately three to five seconds to response

Make it count the first time

## We Have Been Through Strange Times Before

A favorite television cartoon show back in the early 1960s was the Rocky and Bullwinkle show that featured a flying squirrel and a moose fighting the cold war. One segment on that show was a brainy dog, Peabody and his eager boy, Sherman and their "way back machine" that allowed them to go back in time. It made for great entertainment in my early adolescence. Let us imagine that we had a "way back" time machine and we could set the time to go back in time fifty years to the autumn of 1973. Here we go.

The first thing that we would notice is the colorful and weird clothing styles of the day. Patterned flared pants were popular on both men and women. Blue jeans were everywhere, and men's suits had wide lapels and wide neckties as well. The cars were radically different. Muscle cars were still popular, but their day was fading fast.

The #1 song on the charts in October 1973 was "Angie" by the Rolling Stones. Elton John had released perhaps his best album, a double album of songs titled "Goodbye Yellow Brick Road". Other top songs in the autumn of 1973 were Marvin Gaye's "Let's Get it On" and Gladys Knight's "Midnight Train to Georgia".

The most popular movies playing then were "The Way We Were" starring Barbara Streisand and Robert Redford and "The Sting" starring Paul Newman and Robert Redford. Also playing in theatres in the fall of 1973 was "The Exorcist", still one of the best horror movies of all time. On television the most popular programs were "All in the Family" about a lovable bigot in Queens named Archie Bunker. Other favorite shows were The Waltons, Sanford and Son, M\*A\*S\*H, Hawaii Five-0 and Happy Days.

But there were a series of events that happened in the autumn of 1973 that still have relevance fifty years later and may even be repeated. On the holiest day in the Jewish year, Yom Kippur, the Arab nations surrounding Israel launched an attack that caught the world by surprise. The attack was beaten back, and the war was quickly ended.

However, the Arabic nations of the Persian Gulf, disgusted for the United States support of Israel organized an embargo of oil to the United States. At the same time, a new organization, the Organization of Petroleum Exporting Countries (OPEC) dramatically increased the price of oil that was being exported.

The effects were quickly felt back home in the United States as gasoline prices doubled within the space of a few weeks and gas stations were ordered to close on Sundays to conserve gasoline. Then, to conserve gasoline, people with odd numbered license tags could only get gasoline on odd numbered days and the same applied to those with even numbered license tags could only get gasoline on even numbered days. If your day to get gasoline came on a Sunday, you were out of luck.

American car buying habits changed almost immediately. People stopped buying the large sedans that had been the mainstay of the auto industry and fuel economy became a primary buying motive. But American small cars were usually cheaply made cars that were junk. That is when American car buyers discovered that Japanese and European made cars were more fuel efficient and were better built than the smaller American cars. The auto industry was hard hit and never fully recovered.

Politically, the Watergate scandal still dominated the headlines despite the summer's congressional investigation concluding. Under pressure President Nixon had appointed a special prosecutor to investigate any law breaking associated with the Watergate break in and cover up. When a low level staffer revealed during the hearings in July that the conversations in the White House were recorded, the special prosecutor wanted those tape recordings for evidence of the cover up.

President Nixon steadfastly refused to release any of those White House recordings, citing "executive privilege" as President. But the special prosecutor was now seeking a court order to force the President to release those recordings. Finally, on a Saturday night when most Americans were more concerned with the football games, President Nixon ordered his Attorney General to fire the special prosecutor. The Attorney General refused to carry out Nixon's order and was fired. His deputy Attorney General then took over and he also refused and was fired by the President. Finally, the third in command, Solicitor General Robert Bork complied with the President's order and fired the special prosecutor.

The "Saturday Night Massacre" as it was being called in the media shocked the nation and created a firestorm of protest. Even congressional Republicans who had defended the President were appalled. In the House of Representatives on the following Monday, they House voted to begin an inquiry into the impeachment of President Nixon. Public opinion was strongly against the President and most Americans supported impeaching President Nixon.

Eventually the outcry forced President Nixon to appoint another special prosecutor. The struggle to obtain those tape recordings of White House conversations would dominate the news for almost another year. But it was clear in the autumn of 1973 that President Nixon's hold on the presidency was beginning to unravel.

The oil embargo by the oil producing countries in the middle east continued well into the next year and was lifted in the spring of 1974. But that led to a full-blown recession, the most severe since the end of the Second World War. The speed limit on highways was lowered to 55 miles per hour and congress passed new fuel economy standards for cars manufactured in the United States.

Even now, fifty years later, the events from that autumn of 1973 are sill having repercussions in the present day. But there were great songs on the radio as well as great movies in the theatres and great shows on television.

district to make sufficient repairs to bring a building under the 67% threshold, and once again be eligible for OFCC funds.

3) While it is true that a school may be demolished to prevent a charter school from moving into an unused building, state law requires the acquiring school to pay full market value as determined by an appraisal of less than one year, or the district can reject the sale.

The above facts were provided to me from State of Ohio officials and the OFCC itself, none of which have been proven false. https://codes.ohio.gov/ ohio-revised-code/section-3313.411

As I wrote last month, the school board held 2 meetings as a result of that letter. One discussed the cost of a 3rd high school, and the other presented a high-level review of the rebuild vs. refurbish cost of converting the current Parma Senior structure into the "Mega" school. There wasn't any new discussion of the many other potential uses of this building (elementary, middle or temporary high school while the others are refurbished or rebuilt), there also wasn't any new discussion on the master plan that calls for our schools to be demolished, nor has an a appraisal been made by a state certified appraiser.

The district needs modern and improved facilities. However, our district is also facing an operating deficit. This presents a very challenging situation that at some point will involve asking our residents for both a bond to put towards improved building conditions and an operating levy that will pay our teachers, coaches, support staff, and fund opportunities for our children.

This can only be achieved through complete and transparent honesty and a willingness to embrace all options in developing a plan that puts children first and is as considerate to all residents of the three communities as possible. I plan to do my part. The following information was recently shared with me through Governor Mike Dewine's office.

The Ohio Department of Development works to support communities in revitalizing local properties and creating opportunities for improvements through its redevelopment programs. Two redevelopment programs that could potentially help our district or our communities in general are the Ohio Historic Preservation Tax Credit Program and Energy Efficiency Program.

The Ohio Historic Preservation Tax Credit Program provides a state tax credit up to 25% of qualified rehabilitation expenditures incurred during a rehabilitation project, up to \$5 million. To be eligible for this credit a building needs only to be Certified Local Government historic district; or be listed as a local landmark by a Certified Local Government. Note these are local designations that can be established by our local governments, nothing further is required by the state or federal government to become eligible. In the most recent awarding of this credit Lakewood Board of Education Phase 2 and Willoughby Union High School were recipients (these structures will serve the community in a non-educational capacity going forward). https:// development.ohio.gov/community/ redevelopment/ohio-historic-preservation-tax-credit-program

The Energy Efficiency Program helps businesses, manufacturers, non-profits, schools, and local governments modernize buildings with improved energy use – resulting in lower energy costs. https://development.ohio.gov/community/redevelopment/energy-efficiency-program
