

Details of regenerative certification schemes

The RVF is neutral on the subject of whether growers should attain certification, but has been receiving increasing numbers of enquiries on what the different organisations require. This downloadable table has therefore been created to help growers compare some of the key aspects.

Note that this is information that has been compiled from their websites and correspondence with the certifying bodies. Gaps in the table are where the information is not readily available. This will be updated as we receive information from the certifying bodies.

There are some regional wine certifications that are strongly aligned with regenerative agriculture, e.g. Napa Green (which has regen certified producers), Wines of Alentejo Sustainability Program (which has just announced a new regen layer to its certifications) and Bodegas Argentinas Protocolo de Sustentabilidad.
