



Rare modern canvases, formerly from the Krishna and Jean Riboud collection, and F N Souza's iconic *Six Gentlemen of Our Times* lead Saffronart's 25th Anniversary Evening Sale

- Saffronart's 25th Anniversary Live Evening Sale to take place on 27 September 2025 in Delhi, with previews in Mumbai (29 August 2025) and Delhi (25 September 2025).
  - Sale features a 1956 canvas by Tyeb Mehta from the Tyeb Mehta family collection.
- The catalogue includes rare works formerly from the Krishna and Jean Riboud collection, by Indian modernists V S Gaitonde, Akbar Padamsee, M F Husain, and Jagdish Swaminathan.
  - Other highlight lots include prominent works by Jehangir Sabavala, S H Raza, Edwin Lord Weeks, F N Souza, Nicholas Roerich and more.

**Delhi, August 2025:** Founded in 2000, Saffronart has played a pivotal role in shaping the Indian art market, nationally and internationally. Started with a clear vision to create a platform for collecting art that offered transparency, Saffronart was the first Indian auction house to pioneer online auctions and embrace cutting-edge technology, expanding accessibility across geographies and building a platform that democratises access to art and empowers buyers to make informed decisions. Commemorating 25 years this year, the flagship 25th Anniversary Live Evening Sale will take place on 27 September 2025 at The Oberoi in New Delhi.

This year, Saffronart is proud to present five rare lots formerly from the Krishna and Jean Riboud collection as part of the live sale. Krishna Riboud, often regarded as a doyenne of the arts, was born Krishna Roy in 1927 in Dhaka and was raised in Kolkata. Her mother EnaTagore was the niece of Nobel laureate Rabindranath Tagore. Krishnamarried industrialist Jean Riboud, head of Schlumberger, in 1949. The Ribouds lived in Paris and for many years their names resonated in the galleries and salerooms of London, Paris and New York.

The collection in the sale features canvases by Indian modernists such as an *Untitled* lot, 1970 (estimate: INR 18 - 24 crores, USD 2.06 - 2.75 million) by V S Gaitonde, an *Untitled* lot, 1968 (estimate: INR 5.50 - 7.50 crores, USD 632,185 - 862,070) by Akbar Padamsee, an *Untitled* lot (estimate: INR 3.50 - 5.50 crores, USD 402,300 - 632,185) by Jagdish Swaminathan, and two M F Husain works, an *Untitled* lot, 1966 (estimate: INR 3 - 5 crores, USD 344,830 - 574,715) and *Floating Figure*, 1970 (estimate: INR 1.80 - 2.40 crores, USD 206,900 - 275,865).

In a note for the sale catalogue, Delhi based journalist and Krishna Riboud's dear friend Sunil Sethi describes the five works from the Riboud collection, as "examples of high connoisseurship, chosen





by someone whose insight and consummate taste in art was unparalleled."

Six Gentlemen of Our Times, 1955 (estimate: INR 6 - 8 crores, USD 697,675 - 930,235), a set of six pen and ink works on papers, captures F N Souza at his creative peak. Dressed in suits and ties suggesting civility, the "gentlemen" pose stiffly, their sneers betraying self-importance. Souza uses a frontal composition to evoke a sense of monumentality, only to counter it with distortion and irony. Whether political leaders, bureaucrats, judges, or religious figures, they emerge not as true gentlemen but as emblems of corrupted authority and morally bankrupt upper classes.

Also included in the sale is *The Anchorite*, 1983 (estimate: INR 12 - 15 crores, USD 1.37 – 1.72 million) by Jehangir Sabavala. Often archetypal, Sabavala's figures reflect universal themes, and this work—depicting a solitary figure—can be read as a meditation on the artist's own pursuit of the elusive ideal of perfection. *Rajasthan*, 1972 (estimate: INR 18 – 24 crores, USD 2.06 – 2.75 million) by S H Raza reveals the artist's growing fascination with Rajasthan during his travels in the 1970s. He evokes the heat of its scorching desert landscape through a vivid palette of fiery reds, intense ochre, warm greens, and flashes of white with imprecise triangles and squares.

Other highlights include M F Husain's Mahabharata, 1990 (estimate: INR 18 - 24 crores, USD 2.09 - 2.79 million), Trussed Bull by Tyeb Mehta, 1956 (estimate: INR 5 - 7 crores, USD 581,400 - 813,955), Muttra, 1883 (estimate: INR 2.75 - 3.75 crores, USD 316,095 - 431,035) by Edwin Lord Weeks, Nicholas Roerich's Qaraqorum (Karakoram), 1938 (estimate: INR 1.50 - 2 crores, USD 174,420 - 232,560), and an Untitled lot, 1940 (estimate: INR 25 - 35 lakhs, USD 28,740 - 40,230) by F N Souza.
