

OFFICIAL RULES: Visit Berkeley "JULYBATIONS" Staycation (the "Sweepstakes")

NO PURCHASE NECESSARY TO ENTER OR WIN. VALID ONLY IN CALIFORNIA. VOID WHERE PROHIBITED. NEED NOT BE PRESENT TO WIN.

1. Entry: To enter, follow the sweepstakes prompt to complete the registration process. Each entrant will need to provide the following information to be entered into the Sweepstakes: email address. Upon sweepstakes entry, entrants will be given the option to subscribe to the *BARTable This Week* email newsletter. By completing and submitting the Sweepstakes registration during the Entry Period, each such entrant will earn one (1) Sweepstakes entry. Limit of one (1) entry per entrant during the Entry Period. Additional entries beyond the specified limit will be void. All information submitted online via the form will be subject to, and treated in a manner consistent with, Sponsor's privacy policy accessible at bart.gov/siteinfo/privacy.aspx.

2. Sponsor of the Sweepstakes is San Francisco Bay Area Rapid Transit District (BART), 300 Lakeside Drive, (LKS-18) Oakland, CA 94612 ("Sponsor").

3. Entry Period: The Sweepstakes begins on Tuesday, July 13, 2021 at 08:00 AM Pacific Daylight Time ("PDT") and ends on Sunday, July 25, 2021 at 11:59 PM PDT (the "Entry Period"). Sponsor's computer is the official time-keeping device for this Sweepstakes.

4. Eligibility: This Sweepstakes is open only to U.S. legal residents of California who are eighteen (18) years of age or older at the time of entry and have not won a BARTable Sweepstakes in the last ninety (90) days. Employees and agents of Sponsor, their immediate family members and persons residing in the same household of such employees are not eligible to enter or win. "Immediate family members" shall mean parents, spouses, children, siblings or grandparents and each of their respective spouses, regardless of where they reside. This Sweepstakes is subject to all applicable federal, state, and local laws and regulations. Void outside California and where prohibited or restricted by law, rule or regulation. 5. Drawing: On or about Monday, July 26, 2021 ("Drawing Date"), one (1) potential winner will be selected in a random drawing that will be conducted by Sponsor from among all eligible entries received. Entrant need not be present to win.

If potential winner does not respond within twenty-four (24) hours, or if prize notification is returned as undeliverable, prize will be forfeited, and an alternate potential winner will, time permitting, be selected via random drawing from among all remaining eligible entries received. Providing all eligibility requirements are met and potential winner is otherwise in compliance with these Official Rules, potential winner will be declared the official winner of the Sweepstakes. Winner will claim prize on date and location designated in confirmation email from Sponsor.
