AUGUST 23, 2017 August 24, 2017Nur Farzana Md Yusof SOURCE FMT News PETALING JAYA: The Center against Corruption and Cronyism (C4) today criticized the high court's decision to dismiss Rafizi Ramli's appeal against his conviction under the Official Secrets Act (OSA) executive director C4 Cynthia Gabriel, saying the decision was a step backwards, undermining the importance of protecting freedom of information. In a statement, she added that the OSA had been arbitrarily used to conceal corrupt practices and prevent citizens from accessing information related to matters of public interest. It stressed that the use of OSA to punish whistleblowers who expose corruption and mismanagement publicly promotes a breeding environment of corruption, primarily because secrecy allows cases to be squashed without explanation. In the 45 years that OSA came into force, we have seen that the law was used as an effective way to ensure that government data is kept confidential. However, Justice Azman allowed Rafizi to appeal against his conviction on charges of possession on page 98 of the audit report, which was classified under the OSA by the government. He also received a Pandan MP's application for a stay of execution in his 18-month prison sentence pending his final appeal. On November 14, the court sentenced Rafizi Ramli to a total of 36 months in prison on charges of possessing 98 pages of 1MDB inspection reports and disclosing the contents of -- the report at a press conference. The order to the auditor to review 1MDB came from the Cabinet in March 2015, the report was completed and submitted to the Public Accounts Committee (PAC) on March 4, 2016 at the official lying point. It is not clear who is classified, even if the Act requires that, if not within the schedule, citing government decisions and issues related to national security, must be classified by Minister Mentri Besar or the president or other authorized public officials, so who is classified as officially confidential? Ensure that no conflict of interest arises in the classification. The point now is whether the auditor's report should be published under Section 2C of the Official Secrets Act. There are compelling reasons why it's going to take. First of all, this is an examination that the Cabinet needs perfectly justified in doing so, in view of the fact that public money is involved. Therefore, the Cabinet acts in the public interest. However, the cabinet's work is incomplete if they do not consider the full report and if they do not disclose the material publicly. One did not ask for such an important report to be made by the auditor, only to keep his findings confidential. In other words, auditors were taken into the picture to determine if there was any impropriety related to public funds. Therefore, it is the obligation of the Cabinet to supervise the announcement of the auditor's report.
