**UPON THE APPLICATION** of the Plaintiff mother to set this Parenting matter down for Trial; **AND UPON** the parties appearing in Case Management; **AND UPON** hearing from Counsel for the Applicant mother and Counsel for the Defendant / Respondent father;

**IT IS ORDERED THAT:**

1. This Parenting matter shall be set down for a 7-day Trial on \_\_\_\_\_.
2. The specific issues for determination at Trial shall include:
  - a. Parenting arrangements in the best interests of the children;
  - b. Direction as to exchanges and transportation of the children;
  - c. Child Support.
3. Pursuant to Rule 1.4(2)(e) of the Alberta *Rules of Court*, the parties shall comply with the following litigation steps and deadlines:

September 30, 2015	The parties to confirm the number of Trial witnesses for the purpose of completing the Form 37.

October 7, 2015	Counsel for the mother to complete and file the Form 37 (Request to Schedule a Trial Date).
October 31, 2015	Decision as to whether the PN7 report of XXXXX dated XXXXXX, 2015 will be entered as an agreed report without the need to call XXXXXX. Or, if not agreed on then a decision whether one or the other party will be calling XXXXX as an Expert witness.
November 30, 2015	Counsel for the mother to draft a proposed Agreed Statement of Facts for discussion / negotiation.
January 29, 2016	Questioning to take place on or before this date.
February 26, 2016	Any Expert Report to be relied on by either party shall be served on the other party. This does not include the PN7 Report of XXXXX, dated XXXXX, 2015.
March 31, 2016	All Undertakings to be produced.
March 2016	Case Management.
April 29, 2016	Any Rebuttal Report of either party in response to any Expert Report to be relied upon shall be served on the other party.
May 5, 2016	Any Objection to Expert Reports are to be served by either party intending to object to an Expert Report.
June 15, 2016	Any Surrebuttal Report of either party shall be served on the other party.
June 30, 2016	Exchange of Witness lists with "will say" summaries. Exchange of proposed "Agreed" List of Documentary Exhibits. Agreed Statement of Facts to be filed with the Court.
July	Form 39 – Confirmation of Trial Date to be completed by Counsel for the Plaintiff mother in coordination with Counsel for the Defendant father.
30 days before Trial	Counsel for the Plaintiff mother to file the Form 39 (30 days before Trial date).

4. Non-compliance with the time-limits set out herein shall not be cause for an adjournment of the Trial date without leave of the Court.
5. Costs of this Order shall be determined at Trial.
