

# YYYY v. XXXX

## Chronology and Key Facts

DATE	Updated October 27, 2016
August 20, 1979	<p>XXXX born – now 37 years old. Worked for XXXX as a long haul truck driver. Worked early Tuesday morning until Thurs late night. He lives in XXX with SSSS and her daughter VVVV (10 years old). SSSS was the Assistant direct of XXXXX. She is now an Educational Assistant.</p> <p>XXXX’s mom and dad are VVVV and BBBB. They live in Edmonton. They pick up kids from day home on Wednesday afternoon and keep them overnight.</p>
July 7, 1983	<p>YYYY born – now 33 years old.</p> <ul style="list-style-type: none"> <li>• She has 5 other children, but oldest given up for adoption.</li> <li>• AAAA – 14 (dad is XXXX, works in computers, pays CS, but no contact??)</li> <li>• AAAA – 11</li> <li>• AAAA – 9</li> <li>• AAAA – 7</li> </ul> <p>She is at home but worked part-time driving a bus for a few months in 2014. She lives with PPPP in GG – about 10 minutes outside of VVV.</p> <p>YYYY’s mom and dad are XXX and RRR. They live in Edmonton. The VVVV has also been involved as supervisor and writing letters. She is in Edmonton.</p>
June 2011	Started a relationship with YYYY.
July 12, 2011	YYYY obtained a Civil No Contact Order as against XXX, replacing the EPO she got against him.
March 4, 2012	The twins, AAA and XXX were born
March 20, 2012	<p>YYYY was in Provincial Court before Judge Burch getting an Interim Parenting Order for the 3 girls as against XXX. Order gives her primary and him every 2<sup>nd</sup> Sunday from 11 to 4pm supervised in a public place at her discretion!!!! (Seriously????). He was self-repping.</p> <p>XXXX says because she was “<i>fearful</i>” and wouldn’t allow overnights. Took kids to MacDonalds to see him a few times. She would not facilitate phone calls.</p>
April 1, 2012	XXXX moved in.
May 17, 2013	Physical altercation between YYYY and XXXX and the police were called.
May 18, 2013	<p>The last night XXXX spent in the house. He was not allowed to take his property at this time.</p> <p>YYYY called the police after we were fighting about YYYY letting the utilities lapse and get cut off. The utilities were up over one thousand dollars and YYYY had been lying to me about paying them. We were also fighting because YYYY</p>

	was refusing to legally file the taxes with me. The police told me I had to leave. I went to stay on a friend's couch.
May 19, 2013	<p>I came to get my things and YYYY called the police. They told me I had to leave and let me take a bag of clothes. I was not to return and that if I wanted my things I had to go to the courts. I was told if I came back I would be arrested. How is this possible when I was a leaseholder on this house?</p> <p>There was an issue with Yukon truck – He took the licence plate, keys and insurance papers. She did not want him to take them and he said he should just burn the truck and nobody will get it. The police made her park the truck in the back driveway since it was not plated.</p>
May 21, 2013	XXXX stopped payments on the Yukon truck. He notified the rental company he was kicked out and since the lease was up he wasn't signing it. He terminated the utilities in his name. His parents informed her father that the utilities needed to be switched to her name.
May 25, 2013	He was allowed to take some stuff from the house, but YYYY kept his carpet cleaner machine, bedroom suite, projection TV and screen, CCTV system, all kitchen stuff and some clothing (including an expensive suit). Her parents were present. FF was calling him a loser for turning off the power and gas and a deadbeat for not paying CS yet. Her father helped him move the larger items. He finished getting stuff on Sunday, May 26 <sup>th</sup> .
May 28, 2013	YYYY drove to VVV to talk to DDDD, mother of JJJJ. She wanted DDDD to join her to "screw me over". DDDD told XXXX and swore an Affidavit about it.
May 30, 2013	XXXX asked to see the kids. YYYY said only at her house as she would not let them out of her sight. He started the Court process the next week.
June 1, 2013	June 1 - I was allowed to come get my things. YYYY had her mom there. I was only allowed to take what YYYY and FF said that I could or they would call the police again. I got most of my items. The things that they did not allow me to take were : My Brand new king size bed that I bought about a month before, my bedroom suite, my security system for the house, my projection TV and screen, my carpet cleaning machine, my fishing tackle, my fish tank. YYYY kept our twins locked up in the bedroom and I was not allowed to see them.
June 2, 2013	June 2 - I was allowed to clear out the garage. DD helped me lift things. I was not allowed to take my lawnmower and instead was told by DD that I was losing all the things that YYYY was not allowing me to take as "marital property" and that she has every right to keep everything and I should be lucky that she let me have anything at all. I did not get to see the kids this day either.
June 12, 2013	XXXX's parents asked to have the kids for a few hours and YYYY told them she was "not comfortable with the kids being away from her".
May 18, 2013 to June 28, 2013	XXXX did not see the kids a single time. YYYY would not allow him to have them or see them. She blocked his phone number so that he could not contact her and hid them while he moved his belongings out of the home.

**YYYY's Claim & Affidavit #1**

**YYYY filed a FLA Claim and Affidavit #1** in QB with QQQQ at the Family Law Office returnable June 26, 2013. Seeking: Parenting and Child Support. She mentions threats and fear.

**Affidavit #1 sworn June 11, 2013:**

- In relationship from June 2011 to May 2013, 14 months cohabitation.
- Twins born March 4, 2012
- She seeks:
  - Sole decision-making and primary care
  - Reasonable and generous access
  - Child Support commencing June 1, 2013
  - Pay for car loan
  - Costs
- 4 other children – XX who was 12 at the time (now 14), XX – 7 (now 9), XX - 6 (now 8), XX – 4 (now 6).
- She denies he was standing in place of a parent.
- He is working as a long-haul truck driver with XXXX – gone during week, home on weekends.
- May 17, 2013 – argument over bills – “got physical” – **NO PRIOR physical altercations. (MAKE SURE WE HAVE RESPONSE TO THIS)**
- She says he got a gas can and threatened to burn down the vehicle – eventually he calmed down – no damage to the truck. Police called and situation “calmed down”.
- May 20, 2013 – she called the police again when he was hauling things out of the home. He had taken the keys to the Yukon vehicle and disabled the fuel pump – vehicle registered in HIS name but she was driving it. The police directed him to return the keys and leave the truck.
- **She asked for SUPERVISED visits?????? Supervised by her.....???**
- She says she is breastfeeding.
- **She had no problems with his parents coming over to see the kids.**
- She says he was more comfortable with older kids -- but uncomfortable with infants.
- She asks for sole decision-making until he spends more time with them AND “*until our communication improves*”. **HAS SHE TAKEN PAS, FOCIS?**
- She says he threatened to take the kids away from her. In para. 13 she repeats same 2 incidents from May cited earlier to make it sound worse. She was pissed about the truck.
- He cut off EPCOR and Direct Energy – (I assume his version is that he was no longer paying).
- She says he took the twins off his medical benefits (**HE DID NOT DO THIS**)
- Joint loan on 2005 Yukon GMC vehicle – owed \$16,953.26 in June 2013 – monthly payment of \$562.91 plus \$160 for insurance.
- Her income in 2012 was \$4,000.

This Application was served by Sub Service to his parents. They also got a 14 day PAS exemption --- **Do we have proof she took PAS?**
