## **ATL MEMBERSHIP ELIGIBILITY REQUIREMENTS**

Any person who is licensed to practice law in any country, state or jurisdiction, who is of good moral character, is engaged in any field or phase of advocacy, who represents plaintiffs in personal injury cases and is committed to the concept of a fair trial, the adversary system, and a just result for the injured, the accused, and those whose rights may be jeopardized is eligible for membership in the Alaska Trial Lawyers. No one is eligible, however, who engages to represent defendants in personal injury litigation or who is associated with a firm which, more than 10% of the time, represents the defense in personal injury litigation. Persons engaged in criminal prosecution are not eligible for membership.

### **PLAINTIFF'S ONLY LIST SERVER ELIGIBILITY REQUIREMENT**

*Membership on Plaintiff's Only List Server is subject to approval by the ATL Executive Committee*

Any member in good standing of the Alaska Trial Lawyers who represents plaintiffs in personal injury cases is eligible to participate in the Plaintiff's Only List Server. However, with the only exception of an attorney representing a defendant as Chi counsel, no one is eligible who engages to represents any defendant in any personal injury litigation, or who is associated with a firm that represents any defendant in any personal injury litigation. I certify that I meet this eligibility criteria and that if at any time I no longer meet this criteria, I will immediately notify the Executive Director of the Alaska Trial Lawyers. I further certify that I will not forward any E-Mail messages from the Plaintiffs Only List Server to any person not a member of said List Server.
