## General Rules:

Everyone must go through a security screening upon entering the building. Legal photo ID is required. This requirement is waived for high school students entering with a group.

The following items are prohibited: Weapons of any kind, sharp metal objects, cameras or recording devices.

Photography, video, and audio recording and broadcasting are not allowed. Cameras and recording devices are not to be brought into the building. Limited exceptions can be made with two weeks advance notice.

Mobile devices, tablets, and laptops are allowed but should not be used to take photographs, video, or audio recordings. Public wi-fi is not available.

Participants are to remain in the areas designated for the event only.

Food and beverages are only to be consumed in areas specifically designated for that purpose. No food or beverages in hallways or courtrooms.

Failure to obey orders given by the host organization, U.S. Marshals or other court personnel may result in a warning, a school's forfeiture in the event, and/or early termination of the event.

## Courtroom Rules:

Each courtroom is to be monitored by a designee of the host organization. It is up to this monitor to ensure all rules are followed and that concerns are communicated to the court point of contact. Violation of any of the rules may result in a warning, and/or early termination of the event, and/or refusal of future event requests.

No food or drink other than bottled water. NO coffee. NO gum or candy.

No photography or recording.

Do not move any furniture other than chairs.

Do not move or adjust any of the computer equipment or monitors.

Do not disturb papers, etc. that may be left out.

Courtroom tech may not be used, other than microphones. This includes bench conference, evidence presentation, video conferencing, etc.

Participants are to remain in the courtroom and not enter any of the adjacent rooms without specific permission. Jury deliberation rooms, conference rooms, and chambers are not available. Public restrooms are available on each floor.

All trash and loose items are to be picked up and chairs are to be returned to original placement before exiting the courtroom.
