TO RENT A MAILING LIST, YOU MUST FIRST SUBMIT THE CAOC LIST RENTAL AGREEMENT, PAYMENT **AND** A SAMPLE MAILING PIECE, WHICH WILL BE SUBJECT TO CAOC'S APPROVAL. CAOC RESERVES THE RIGHT TO REFUSE ANY ORDER FELT INAPPROPRIATE FOR MEMBER PROMOTION, OR IN CONFLICT WITH CAOC SEMINARS, PRODUCTS OR IDEALS. **TELEMARKETING AND SPAMMING ARE STRICTLY PROHIBITED.** THIS LIST IS CONFIDENTIAL AND IS APPROVED FOR RENTAL ON A CASE-BY-CASE BASIS (limit of 3 purchases annually for use).*

LIST RENTAL FEES

CAOC Members: \$00.50 per label (\$500 for statewide list)

Non Members: \$1.00 per label

SHIPPING AND HANDLING OPTIONS

UPS 2 Day Air: \$30

Next Day Delivery: \$65

- All fees are subject to sales tax.
- Full payment and completed list order form must be received by CAOC before the list will be shipped. CAOC will accept major credit cards over the phone.
- A cancellation fee of \$50 will be charged if the order is cancelled after the list has been produced but before it has been shipped.

The purchaser understands and agrees that CAOC's liability, whether from negligence or otherwise, resulting from the member's use of the lists, shall be limited to the sale price, and in no event shall CAOC be responsible for consequential or similar damages. This Agreement is subject to cancellation by CAOC in its sole discretion.

The member also understands and agrees that all terms and conditions of this Agreement should apply and shall be incorporated by reference into any future purchases of CAOC lists.

CAOC's lists are salted to monitor usage. Prohibited usage will be subject to a \$2,000 fine and legal action.
