NONPROFIT CORPORATION NOTICE

Notice is hereby given that Articles of Incorporation were filed in the Department of State of the Commonwealth of Pennsylvania, at Harrisburg, Pennsylvania, on the 16th day of May 2001, for the purpose of incorporating a nonprofit corporation under the Pennsylvania Nonprofit Corporation Law of 1988.

The name of the corporation is KENNETT SQUARE KAU LITTLE LEAGUE, INC.

The purposes for which it is to have been organized are to oversee, operate and manage a community-wide baseball little league to serve youths in the general areas of Kennett Square, Avondale, West Grove and Unionville, Chester County, Pennsylvania.
