Aaron Tobin Elected Dallas Bar Association President

The **Dallas Bar Association**, a 148-year-old professional, voluntary organization comprised of more than 11,000 lawyers in the DFW Metroplex, will inaugurate its 112th President in January. Leading the association in 2021 will be **Aaron Z. Tobin**, an accomplished trial attorney and named partner at Condon Tobin Sladek Thornton Nerenberg.

Mr. Tobin joined the Board of Directors in 2012 and was elected Chair of the Board of Directors in 2017. He has served as Chair of numerous DBA Committees, including the Finance Committee, Morris Harrell Professionalism Committee, Public Forum Committee, and Bench Bar Committee. He served as Co-Chair of the *2012-2013 Campaign for Equal Access to Justice*, for which a record amount of money for low-income families and individuals was raised. The Campaign funds the Dallas Volunteer Attorney Program to provide free legal assistance to over 4,000 low-income families with civil legal needs each year.

He is a Fellow of the Dallas Bar Foundation and the Texas Bar Foundation, and a Life Fellow of the Dallas Association of Young Lawyers Foundation.

Mr. Tobin received his J.D. from Southern Methodist University School of Law. In addition to his bar service, Mr. Tobin is a Master at the Patrick E. Higginbotham American Inn of Court, has served on the Board of Directors for The Conservancy, as a volunteer for Big Brothers, Big Sisters of North Texas, and as a Co-Chair, Affair of the Art, Junior Associates, of the Dallas Museum of Art. He has received numerous awards including DBA Presidential Citations and recognitions on *Best Lawyers in America*, Texas Super Lawyers, and Thompson Reuters Texas Rising Stars lists.
