The Dallas Bar Association conducts a judicial evaluation poll in years that precede general elections. The poll includes judges who have served for a period of at least one year in a judicial office for which admission to the State Bar of Texas is a statutory prerequisite. The Dallas Bar Association Board of Directors, with the assistance of the Judiciary Committee, determines the form of the poll. Questionnaires are sent on the third Monday of May by regular or electronic mail to members of the Dallas Bar Association. To be included in the results, questionnaires must be completed and returned to the Dallas Bar Association within fifteen days of the date of mailing or electronic transmission. The results of the poll are summarized as soon as practicable and communicated to the members of the Dallas Bar Association. In 2007, a Judicial Poll Study Subcommittee of the Dallas Bar Association Judiciary Committee found no evidence of racial, gender, or age bias in the methodology or questions posed by the Judicial Evaluation Poll. The Judiciary Committee of the Dallas Bar Association conducted a judicial evaluation poll of the Association's membership between May 15, 2017 and May 30, 2017. Of the 9,205 members of the Association, 894 responded to the questionnaire.

The questionnaire was sent to all members of the Association by regular or electronic mail. Each member was required to certify that his or her responses to the questionnaire were based on personal, first-hand knowledge of each judge's performance obtained within the last four years, and such knowledge was required to rise to such a degree that he or she was reasonably able to evaluate the judge's performance. If a member was qualified to evaluate a judge and chose to do so, he or she could express a "No Opinion" in response to any particular question with respect to that judge.

The following tables present the results of the poll. Under each judge's name is "Total Ballots," which means the total number of lawyers who responded to at least one question for that judge with an "Excellent," "Acceptable," or "Needs Improvement" response. The "Number of responses" is the total of the "Excellent," "Acceptable," and "Needs Improvement" responses to each question. The "Excellent%," "Acceptable%," and "Needs Improvement%" column represent the percentage breakdown of the "Number of Responses" for each question only. The difference between the "Number of Responses" on any given question and the "Total Ballots" for each judge is attributable to the "No Opinion" responses. Due to rounding, the percentages for some questions do not total to 100%.

Also presented below is a table that reflects the demographic characteristics of the members who participated in the Judicial Evaluation Poll. Each member had the option of not submitting demographic information. Of the 894 members of the Association who responded to the questionnaire, 778 members (87%) chose to submit some demographic information with the questionnaire.
