


# GRBA Electronic Voting - Voter Experience Guide

In the coming weeks, you receive an email providing a username, a password, and a link to the election site.

Once navigating to the voting site, you will see a login screen, similar to the one below.

Next, you will be directed to the ballot page where instructions are available in a floating screen to the left of the candidate choices.

Once you have reviewed your votes, you will submit them via the submission page. You will receive a confirmation and will be able to print or email a receipt of your vote for your records.
