Law Week Sponsor \$4,000

This sponsorship covers all things Law Week related outside of the contest prizes, such as contest expenses, complimentary tickets for our 1st place winners and their guests to the HYL A Law Day Luncheon, webinar recording fees, and books for our Law Week Reading program in elementary schools across Harris County. We have Law Week activities from October-May so recognition would be frequent across the bar year.
