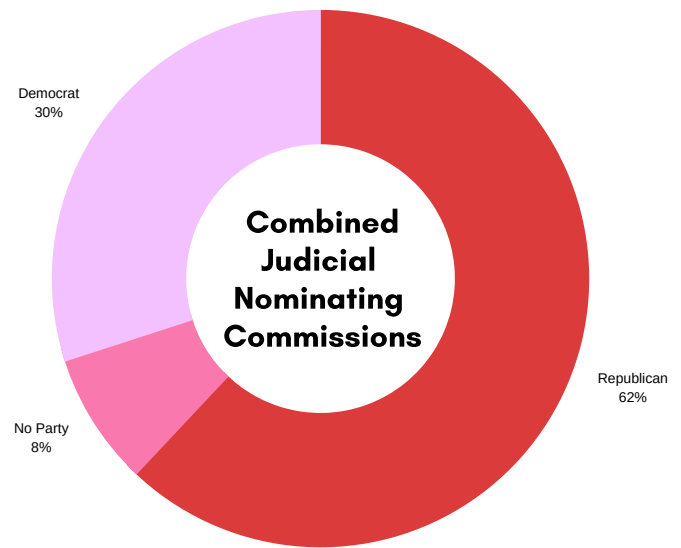
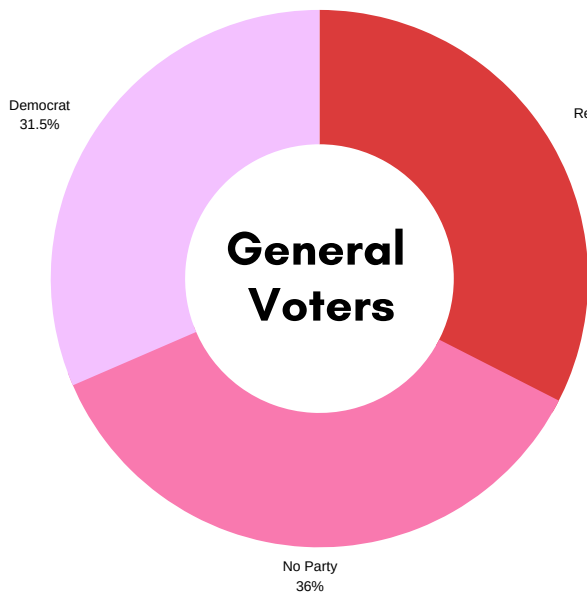


Political makeup of Iowa's District & State Judicial Nominating Commissions
