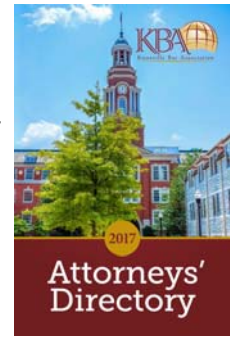

## KBA Mailing Label Policy

### ***This release is for KBA Members Only.***

Members	\$ 50
Non-Members (announcements)	\$200
Non-Profit Organization	\$100 (At discretion of Executive Committee)
CLE Provider	\$300
For Profit Solicitation (other than CLE)	\$500 (At discretion of Executive Committee)

As a service to KBA members, the Board of Governors adopted a policy which permits members to obtain a set of KBA mailing labels in order to send announcements, address changes, invitations, etc. Members will be asked to sign a release stating that the labels will not be released to any non-KBA member in order to protect members from receiving unwanted solicitations. If a member wishes to use the KBA mailing labels to solicit business or for any other non-charitable profit making endeavor the Board of Governors has determined that a \$500 charge is appropriate with the benefit to KBA members outweighing the potential for members receiving unwanted solicitations from other members. The KBA will also make available to members CD ROMs which contain the mailing list for a charge of \$150.00. Members will be asked to sign a release stating that the mailing list will not be released to any non-KBA members and will not be used for solicitations for profit, without prior approval from the Executive Committee and the \$500.00 payment reflecting a For Profit Solicitation.

*This policy was approved by the KBA Board of Governors on November 15, 2000 and amended by the KBA Executive Committee on August 15, 2001.*
