## W. THOMAS DILLARD 2002 RECIPIENT OF THE KBA GOVERNOR'S AWARD

At the annual meeting on December 13, 2002, W. Thomas Dillard was presented the Governor's Award by the Knoxville Bar The Governor's Award is an Association. annual award given by the Association to a member felt by the Board of Governors to be exemplary both as an attorney and as a community citizen. This award is designated as the highest award of the Association for a practicing attorney. The recipient has no advance knowledge of the receipt of the award and does not even know he/she is being considered for such an award.

Tom Dillard is the Managing partner of Ritchie, Fels & Dillard, PC in Knoxville, Tennessee and developed a passion for the law as a result of an incident which occurred when he was 18 years old. During a snowstorm, some students at the University of Tennessee were throwing snowballs and spinning cars. Tom was an 18yearold student and was arrested by four police officers several blocks away from the commotion. He was innocent and appeared eight times in court only to have the case postponed. Later the charges were dropped. Tom determined that he would be a lawyer. As a lawyer, Tom was resolute that he would be compassionate. Thereafter, whether defending or prosecuting, Tom has done his best to make sure the system works. He knows that you can be wrongfully accused.

Having graduated from the University of Tennessee College of Law in 1964, he served nine years an as Assistant U.S. Attorney in
