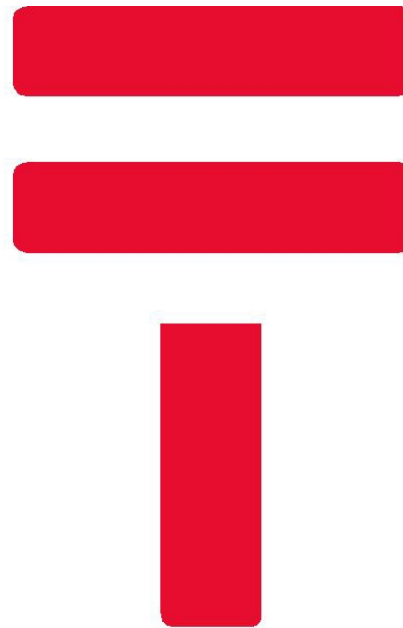

MEMBERSHIP CRITERIA AND ATTESTATION

In addition to other criteria*, the Minnesota Association for Justice requires that no person shall be eligible for membership who, for the most part, represents the defense of personal injury or employment litigation; and no information or services received from the Minnesota Association for Justice shall be used for the defense of personal injury or employment litigation.

A member shall be deemed a member in good standing after a signed application form is submitted, reviewed, accepted and membership dues are paid. Upon acceptance, the signed application will serve as attestation to the membership criteria outlined in the MAJ bylaws.

Tax Statement

Dues, contributions or gifts to the Minnesota Association for Justice (MAJ) are not tax deductible as charitable contributions for federal income tax purposes. However, they may be deductible as ordinary and necessary business expenses, subject to restrictions imposed by MAJ's lobbying activities as defined by the Budget Reconciliation Act of 1993. MAJ estimates that the nondeductible portion of your 2019 dues, contributions or gifts – the portion that is allocable to lobbying – is 11%. **We strongly recommend that you discuss any potential tax deduction with a tax professional.**
