The North Carolina Advocates for Justice is a non-profit independent association dedicated to protecting people's rights through professional and community legal education, championing individual rights, and protecting the safety of North Carolina families in the home, in the workplace, and in the environment.

The North Carolina Advocates for Justice was formed over 50 years ago by a small group of trial lawyers who wanted to protect people's rights. Today, the North Carolina Advocates for Justice has almost 3,000 members and is one of the top protectors of individual rights in North Carolina. They represent those injured by the wrongdoing of others, workers, the disabled, those with family problems, consumers, those in debt, and those accused of a crime.

The North Carolina Advocates for Justice has provided the Latino Community with legal advice and representation on civil, criminal, and immigration matters. NCAJ members have advocated for people's rights in the General Assembly on issues such as the civil justice system, making it open and accessible to everyone; a worker's compensation system that is fair to injured workers; and increased funding for indigent criminal defense and the justice system generally. Lastly, members of NCAJ have also provided pro-bono services to the Latino Community.
