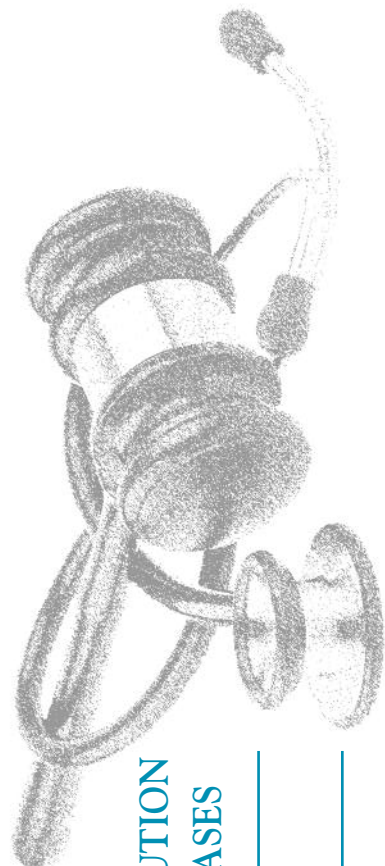

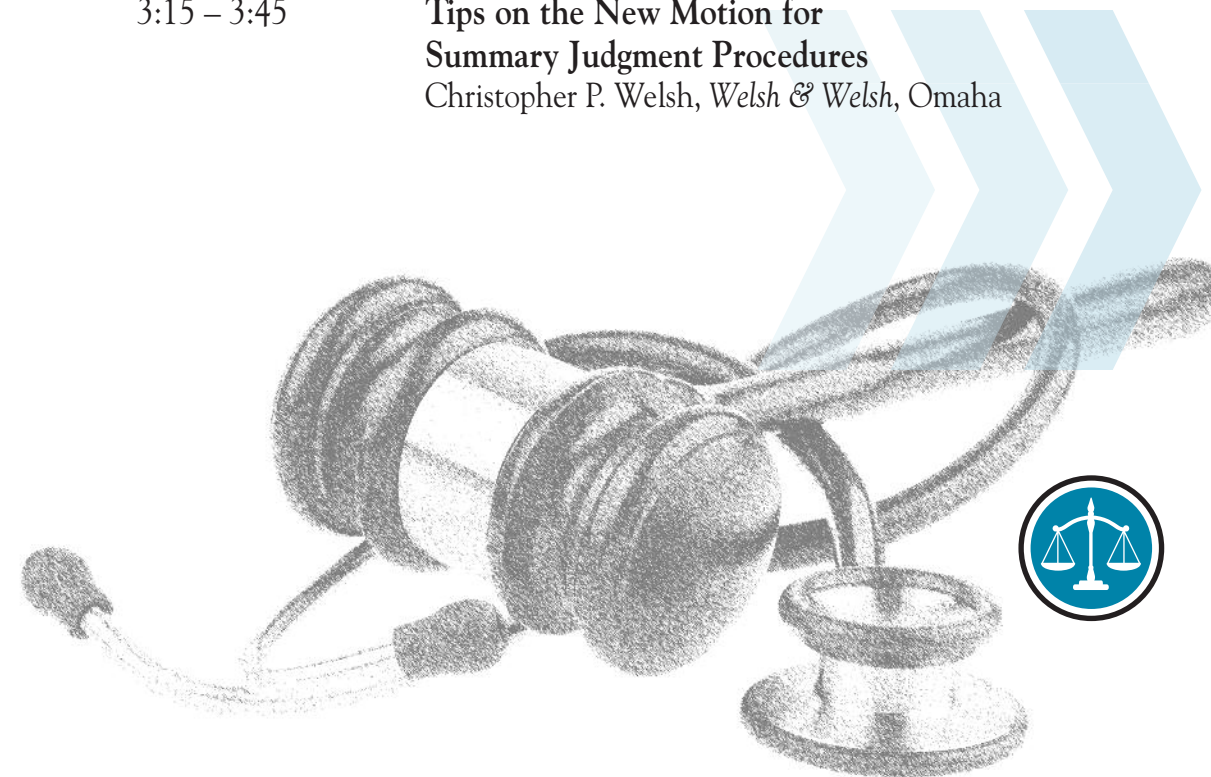

**INFORMATION FOR REGISTRANTS**

**SEMINAR REGISTRATION FEES:**
