**Re: Support Critical Resources for the Federal Judiciary**

Dear Member of Congress:

The undersigned 27 organizations represent a diverse array of nonpartisan groups that care deeply about civil and human rights, which are threatened by the current lack of resources provided to the federal courts. As Congress returns to the task of considering the budget for Fiscal Year 2014, we call your attention to the need for adequate funding for the federal judiciary.

Sequestration has translated into a cut of roughly 5% in appropriations for the federal judiciary. According to the Administrative Office of the United States Courts, sequestration has meant budget cuts of \$350 million for the federal courts. Some segments of our federal judiciary, such as the Federal Defender system, seem to have suffered disproportionately.<sup>1</sup> These cuts threaten to erode several core constitutional values, including the right to a jury trial and due process, and threaten to make illusory key statutory rights, such as the right to a speedy trial.

In a year when this nation marks the 50<sup>th</sup> anniversary of both *Gideon v. Wainwright* and the March on Washington for Jobs and Freedom, we are reminded of the role that courts have played, and can continue to play, in the struggle for equality and justice. However, the courts cannot play this role if they lack the necessary resources. Whether it be addressing the judicial vacancy crisis, acting on the nonpartisan Judicial Conference's recommendations to increase the number of authorized federal judgeships, or passing a budget that provides desperately needed funding to our nation's federal courts, we ask for your help to protect this critical branch of government. We make this request not for the judiciary, but for its ultimate beneficiaries --- the people who depend upon it for the protection of their fundamental rights and freedoms.
