- assist new attorneys by providing them someone to whom they can turn to ask questions;
- introduce them to other members of the Bar and Bench;
- allow Mentors an opportunity to accompany new attorneys to Association events on occasion; and
- assist new attorneys to get involved in OCBA activities and take advantage of OCBA membership.

How the program works:

When a new attorney is admitted, they are given an opportunity to request a Mentor. The Mentor will be notified via fax stating that the new admittee has been given your name. **It is the responsibility of the assigned Mentor to make the original contact.** The Mentor Program encourages a high level of competence, civility and professionalism among Oakland County attorneys.
