- (https://reviewer.efiletexas.gov/). Only essential matters will be heard in person pursuant to the Court of Criminal Appeals Order (No. 20-008). If you have an essential matter that needs the court's attention, you should contact the court coordinator to have the matter referred to the presiding court or jail court. No motions will be considered unless they are e-filed and urged to the court for consideration. You can urge the court to review a motion by notifying the coordinator of the filing.
- 2) Will be allowed to file attorney vouchers without the requirement of a notary signature.
