**SAN DIEGO BAR ASSOCIATION MEMBERSHIP:** San Diego County Bar membership offers opportunities to network with others in the legal profession. Through structured activities and informal gatherings, attorneys may interact with colleagues, judges and business leaders, while building powerful and valuable professional contacts. The SDCBA uses the following descriptions for membership.

- **ATTORNEY:** Anyone licensed to practice law in any US jurisdiction with an “active” license in good standing without pending or current disciplinary action is eligible for attorney membership. Dues are based on first licensure date.
- **LAW SCHOOL GRADUATE:** Any law school graduate within two years from graduation and not licensed to practice law.
- **JD:** JD degree 2 or more years ago and not ever licensed to practice law in any US jurisdiction.
- **ASSOCIATE MEMBER:** Paralegals and other legal community professionals working within a law firm are eligible to become Associate Members of the SDCBA if not licensed to practice law in any US jurisdiction.
- **EXEC:** Executive Directors and Staff of SD legal community organizations who are not licensed to practice law or with a JD.
- **INACTIVE LICENSURE:** Licensed in a US jurisdiction but that license is currently not active (not due to disciplinary action.)
- **LAW SCHOOL FACULTY:** Any person employed full-time as faculty in a law school.
- **VENDOR:** Vendors supplying products and services to the legal community and without an active license to practice law.

**NEW LAWYER FORUM (Forum) :** Attorneys in their first 2 years of practice will be automatically opted into the Forum, and all attorney members may participate in the Forum through their first 4 years in practice. Forum members: enjoy special networking events designed just for new attorneys, participate in an annual community service project created and managed by Forum members, network in a community comprised of your peers, share resources and ask questions through a two-way listserv and online file share.
