2021 Contest Theme: "ADVANCING THE RULE OF LAW NOW"

Focus Points: Emphasis on the rule of law in the foundation of our nation and recognition of its importance for society.

Eligibility: Tulsa County students of public, private and home schooling (pre-K through 12th grade). Each grade has one or more contests. See page 2.

Dual Entry Option: *Automatically* enter the Tulsa County Bar contest by entering the OBA contest by January 15, 2021.

- Entry to the Oklahoma Bar Assn. (OBA) contest **must be received by Friday, January 15, 2021**. Mail entry to OBA Law Day Committee, P.O. Box 53036, Oklahoma City, OK 73152, or deliver entry to the Oklahoma Bar Center at 1901 N. Lincoln Blvd., Oklahoma City, Ok 73105.

Single Entry Option: Enter the Tulsa County Bar contest directly.

- Entry **must be received by Friday, April 9, 2021**, mailed or delivered to the Tulsa County Bar Center, 1446 South Boston Avenue, Tulsa, Ok 74119.

Prizes:

- Each bar association has different prizes.
- In the Tulsa County Bar contests, students can enter (and potentially win) both the Writing and Art contest prizes for their grade level (there are no second place prizes).
- If a Tulsa County student is an OBA contest winner, they are not eligible for the *same* contest in the Tulsa County Bar competition.
- Entries may not be considered for insufficient theme or non-adherence to other contest rules.
- The Tulsa County Bar contest is limited to Tulsa County students unless no other Tulsa County entries are received or fail to meet rule criteria.

Winners' Names Published: 2021 OBA and Tulsa County Bar contest winner names and school may be published on the OBA and/or Tulsa County Bar websites and/or in the Oklahoma Bar Journal or other community publications. The entry of student may be displayed as well, with name and school, in the State of Oklahoma or elsewhere.

Teacher or designated adult are expected to inform the student and parent or guardian of awards and recognition ceremony event. Target date to announce Tulsa County Bar contest winners is April 27, 2021.

Tulsa County Bar Rules for Each Grade's Contests:

Coloring Contest (Pre-Kindergarten & Kindergarten-Transitional First)

- Prizes: \$35.00 to winner for each grade level.
- Coloring sheets will be available on the OBA website (see page 1) or the Tulsa County Bar website (above)
- Judging based on quality and artistic presentation

Art Contests (1st Grade through 12th Grade)

- Prize for each grade level: 1st grade and 2nd grade \$35.00; 3rd grade and 4th grade \$50.00; 5th grade through 8th grade \$60.00; 9th grade through 12th grade \$100.00
- Examples of entries might be used to document student community service project (digital or DVD format preferred), a video production, mixed media artwork, original music, creative writing, poetry, photography, collage and anything else that relates to the contest theme
- If you'd like guidance for subject matter, see "Writing Contest Prompts" & "Lesson Plans" consult OBA website or Tulsa County Bar website
- Group submissions are accepted and will be judged at the grade level of the group member in the highest grade
- Judging based on originality, adherence to theme, quality and presentation

Writing Contests (1st Grade through 12th Grade)

- Prize for each grade level: 1st grade and 2nd grade \$35.00; 3rd grade and 4th grade \$50.00; 5th grade through 8th grade \$60.00; 9th grade through 12th grade \$100.00
- Students may respond to a prompt based on his or her grade level provided by the Law Day 2021 websites
