**ORDER OF SUMMARY SUSPENSION FOR NONCOMPLIANCE WITH
TENNESSEE SUPREME COURT RULE 9 SECTION 10 FOR
NONPAYMENT OF ANNUAL REGISTRATION FEE**

Pursuant to Tennessee Supreme Court Rule 9, Section 10.5, the license to practice law in this State of the following listed attorneys is summarily suspended for failing to timely pay the Board's annual registration fees. Pursuant to Rule 9, Section 10.1, the annual registration fee is due and payable to the Board of Professional Responsibility on or before the first day of the attorney's birth month of each year.
