

## **TBA Annual Public Service Awards**

Each year the Tennessee Bar Association recognizes outstanding service by attorneys and law students who have demonstrated an exceptional commitment to increasing access to justice for underserved individuals and communities in Tennessee.

Awards are presented at the Annual Public Service Awards Luncheon, which is held as part of the TBA Leadership Conference. The 2014 Public Service Award Winners will be honored at the 2015 Luncheon on **Saturday, January 10** in **Nashville**.

### **Awards are presented in three categories:**

- Ashley T. Wiltshire Public Service Attorney of the Year - recognizes an attorney for an indigent client in either civil or criminal defense who provided dedicated and outstanding services during the past year
- Harris Gilbert Pro Bono Volunteer of the Year Award - recognizes significant pro bono work by a private attorney
- Law Student Volunteer Award - recognizes a student who has provided dedicated and outstanding pro bono services to an organization that is primarily engaged in providing legal representation to the indigent

This award is given to an attorney who has contributed significant amounts of pro bono work, either in terms of numbers of cases handled or significance of the work as well as one who demonstrates dedication to the development and delivery of legal services to the poor. *The work must have occurred within the last 3 years.*

- (1) Describe what the nominee has done to contribute a significant amount of pro bono work within the last 3 years, either in terms of number of cases handled and/or significance of the work. Provide specific information including, as applicable, the number of hours spent, the number of cases worked and the types of cases, the impact of an outcome in a significant case. (400 words)
- (2) Describe what the nominee has done to demonstrate dedication to the development and delivery of legal services to the poor. (300 words)
- (3) Describe what sets this nominee apart from his/her colleagues in the field. (200 words)
- (4) If available, please provide additional material in support of the significance of the work and/or demonstrated dedication to delivery of legal services to underserved, including copies of media coverage, client comments, judicial comments, copy of judicial opinions resulting from the work, evidence of recognition of employer or other similar information. *This material should be emailed to Liz Todaro at [ltodaro@tnbar.org](mailto:ltodaro@tnbar.org) no later than Friday, September 5, 2014.*
