**ORDER OF SUMMARY SUSPENSION FOR NONCOMPLIANCE WITH
TENNESSEE SUPREME COURT RULE 9 SECTION 10 FOR
NONPAYMENT OF ANNUAL REGISTRATION FEE**

Pursuant to Tennessee Supreme Court Rule 9, Section 10.5, the license to practice law in this State of the following listed attorneys is summarily suspended for failing to timely pay the Board's annual registration fees.
