**ORDER OF SUMMARY SUSPENSION FOR NONCOMPLIANCE WITH  
TENNESSEE SUPREME COURT RULE 9 SECTION 10 FOR  
NONPAYMENT OF ANNUAL REGISTRATION FEE**
