**ORDER OF SUMMARY SUSPENSION
FOR FAILURE TO PAY PROFESSIONAL PRIVILEGE TAXES**

Pursuant to Tennessee Supreme Court Rule 9, Section 26, any attorney who holds an active Tennessee law license is required to pay an annual Professional Privilege Tax to the Tennessee Department of Revenue. Any attorney who is deemed to be non-compliant for at least ninety (90) days or more is subject to summary suspension. Failure to timely pay these taxes shall result in the attorney being summarily suspended from the practice of law.

Based on the foregoing, the license to practice law in this State of each of the following listed attorneys is summarily suspended upon representation of the Board of Professional Responsibility that the required notices pursuant to Tennessee Supreme Court Rule 9, Section 26.3, have been given and that the listed attorneys have failed to pay the Professional Privilege Tax for 90 (ninety) days or more as required by Tennessee Code Annotated 67-4-1702.
