Dear Billing Records Custodian:

This firm has been retained to represent **(Client)** in connection with the injuries she suffered in an accident on (date of accident). I understand that **(Provider)** provided medical treatment to **(Client)**.

Please provide me with copies of billing records for **(Client)** from the date of accident to the present. Enclosed is a Medical Authorization and Billing Affidavit for a set of records.

In completing the last paragraph of the Billing Affidavit, please note a major change in the law required by the June 2011 *Escobedo* decision by the Texas Supreme Court. The Court held that the total charges are no longer admissible into evidence. Instead, only the amounts actually paid plus the unpaid balances are admissible. **Accordingly, in the last paragraph of the Affidavit, the only amounts to be entered are:**

1. **THE TOTAL AMOUNT PAID IN THE FIRST BLANK.**
2. **THE AMOUNT CURRENTLY UNPAID BUT STILL OWED IN THE SECOND BLANK-** i.e. balance remaining after all payments and insurance/Medicare/Medicaid contractual write-offs is \$500- enter \$500 in this blank.

Please note, if the balance has been turned over to collections, please list the amount owed to collections; we cannot collect for a zero balance.

Additionally, please note that we would prefer to have the billing records sent electronically to attorney@ostovichlaw.com.

We apologize for the inconvenience presented by this new law, but if it is not complied with, the Affidavit is legally useless and we will have to send it back to you so that it can be completed correctly. Please contact me at 940-761-2000 should you require additional information. Your assistance and cooperation is greatly appreciated.

BILLING AFFIDAVIT

BEFORE ME, the undersigned authority, personally appeared _____, who, being duly sworn by me, deposed as follows:
