Eligibility Certification: Any lawyer licensed to practice before the Vermont Supreme Court, being of good moral character, engaged in any field or phase of advocacy and committed to the concept of fair trial, the advocacy system and a just result for the injured, the accused and those whose rights are jeopardized, is eligible for membership in the VTAJ. Provided, however, that no person shall be eligible for membership or continue membership who regularly or consistently represents the defense in personal injury or workers compensation matters, or who is affiliated with a firm which regularly or consistently represents the defense in such matters. "Regularly or consistently" means in excess of 10% of an individual or firm's personal injury or workers compensation representation, measured by any one or more of the following factors: percentage of gross receipts, time spent, number of matters, or number of clients represented during the past calendar year.
 By signing below I certify that I meet the membership qualifications of the Vermont Association for Justice. I understand that a misrepresentation of my qualifications may constitute, and may be reported as, a violation of Rule 8.4 of the Vermont Rules of Professional Conduct.
