The cases are divided into five categories: Personal Injury/ Property Damage (PI/PD), Contracts/Real Estate, Other Civil, Family and Small Claims. While the Director of State Courts uses the same five categories of cases, it defines certain types of cases differently than the Wisconsin Court Filings table. Specifically, the following changes have been made: Minor Settlements are moved from Contracts to PI/PD; TROs for abuse and harassment are counted in Family rather than Other Civil.
