

## The Workers' Injury Law & Advocacy Group

### TERMS OF USE

By accessing or using the Workers' Injury Law & Advocacy Group ("WILG") website, [www.WILG.org](http://www.WILG.org), (the "Site"), you agree to comply with and be bound by these Terms and Conditions of Use ("Terms of Use"). Please read these Terms of Use carefully, as well as WILG's [Privacy Policy](#), which is incorporated herein by reference. **IF YOU DO NOT AGREE TO THESE TERMS OF USE AND THE PRIVACY POLICY, YOU HAVE NO RIGHT OR LICENSE TO ACCESS THE SITE AND MUST IMMEDIATELY TERMINATE YOUR USE OF THE SITE.**

**1. terminate these Terms of Use. These Terms of Use will terminate automatically if you fail to comply with the terms set forth herein. Governing Law.** These Terms of Use and all matters regarding your use of the Site shall be governed by, construed in accordance with, and enforced under the laws of the State of New Hampshire applicable to contracts made and executed and wholly performed in the State of Wisconsin, without regard to choice of law principles. **21. Waiver and Severability.** The failure of WILG to exercise or enforce any right or provision in these Terms of Use shall not constitute a waiver of such right or provision. If any provision of these Terms of Use is found by a court of competent jurisdiction to be invalid, illegal, or unenforceable, such provision shall be enforced to the fullest extent of the law, and all other provisions shall remain in full force and effect.

**22. Complete Agreement.** These Terms of Use, together with any revisions, any Additional Terms or Conditions incorporated by reference, and any Click-through Agreement, constitutes the entire agreement between you and WILG relating to the Site and its use by you, and supersedes any previous written or oral communication regarding use of the Site.
