

Scope of the Appraisal

The purpose of this document is to create an independent, professional appraisal which provides the Fair Market Value of the machinery and equipment of Pro Source Rent/All, Inc. to assist with business management decision making.

Pro Source Rent/All, Inc. is an equipment rental company serving the general public. The equipment in this appraisal includes pickup trucks, trailers, brush chippers, chain trenchers, boats, personal watercraft, man lifts, scissor lifts, crawler mounted compact excavators, telescoping boom rough terrain lift trucks, skid steer loaders, truck tractors, ag tractors, towable air compressors, miscellaneous machinery and equipment, office furniture, office equipment, certain inventory and more. This report does not include software, real estate, intangible assets, etc.

Value Conclusion

Based on my investigation, analysis, and methods used, it is the opinion of Miedema Appraisals, Inc., considering the stated assumptions, conclusions and limiting conditions that the total Fair Market Value of the machinery and equipment of Pro Source Rent/All, Inc. in this report is:

Analysis and Date of the Appraisal

The effective date of this appraisal is January 8, 2018, and is subject to the market influences and economic conditions that existed on that date only. Any uses for this report outside of this date may be null and void without a signed update from a qualified appraiser. This report is intended to be used by Pro Source Rent/All, Inc. to assist with business management decision making, and is not intended for any other use.



Most of the major machinery in this appraisal is commonly used in the construction and rental industries, which is what the machinery was designed and manufactured to do. Continued use in these industries is the highest and best use of the assets in this report. The most common markets for this type of equipment are end users of the equipment and used equipment dealers that sell to end users. The information used to confirm the values given in this report come from those sources. Efforts to sell the equipment, if it becomes necessary, should be on a local, regional, national and international level in order to target the proper buyers. Much of their equipment is in average condition for its age and use and appears to be maintained well to meet the rental industry standards. Current market conditions for this type of equipment are steady, and the values in this report reflect these conditions.

The national economy has shown sustained growth and we are optimistic that it will continue to strengthen. This report is an estimate of value of Pro Source Rent/All, Inc.'s machinery and equipment as of the effective date of this report. The reader of the report should be aware that unforeseen volatility of the economy could affect the values of the assets in this report at any time.

Value Definition

The objective of the appraisal is to estimate the "Fair Market Value" of the equipment.

The "Fair Market Value," hereinafter referred to as "FMV," is the amount, expressed in terms of money, that may reasonably be expected in an exchange between a willing buyer and a willing seller, with equity to both, neither under any compulsion to buy or sell and both fully aware of all the relevant facts as of the date of the appraisal. This definition of value assumes that the equipment would be removed to a new location.

This definition is taken from the American Society of Appraisers Machinery and Technical Specialty Committee's definitions.

Any users of this report must assume that this equipment would be adequately marketed by qualified and experienced brokers. The "FMV" listed in this report is the probable value for which the item would sell to the new owner and does not take into consideration expenses, such as advertising and commissions, involved in that sale.

Appraisal Methodology

Once the appraiser establishes the appropriate markets and definitions for the appraisal, he or she must consider the three accepted approaches to determining value:

The **Cost Approach** is an estimate of the cost to reproduce an exact replica of the subject property or the cost of replacing the subject property with a property of the same or like utility less accumulated depreciation. Depreciation includes losses in value due to physical deterioration as well as functional and economic obsolescence. Physical deterioration includes, but is not limited to, abuse, age, wear and tear and other factors that occur over time and with use. Functional obsolescence is the decreased ability of the item to perform the function for which it was intended. For example, a machine may be fully functional, but a newer model of the same machine may be able to perform the same function twice as fast with the same quality. The difference in speed is functional obsolescence. Economic obsolescence represents a loss in value from factors outside the appraised item such as a downturn in the economy causing a depressed demand for the end product produced by a machine that in turn could reduce the value of the machine. All of these factors must be analyzed and quantified by the appraiser and applied to the replacement/reproduction costs to determine an indication of market value.

The Sales Comparison Approach involves researching recent sales and offerings in the appropriate marketplaces of the same or similar equipment. Ideally, the sales of the same equipment under the same market conditions provide the most reliable source of data to determine an indication of current value. However, exact comparisons are not always available, so the appraiser must look at the sales of similar equipment and make adjustments in these sales to compensate for the differences to arrive at an indication of its current value.

The **Income Approach**, which considers the present worth of the future benefits of ownership, is not usually used when appraising individual pieces of personal property. The Income approach is generally used to value the aggregate of the assets that generate income for a business. The income approach was considered and deemed not applicable in performing this appraisal.

In completing this appraisal, I relied primarily on the Sales Comparison approach since actual recent sales of a property most accurately reflects its current value in an appraisal of this type. I paid particular attention to the marketability of the assets in their geographic location to arrive at the most probable values for the machinery and equipment listed. I used the Cost approach as a comparison when sufficient Sales Comparison data were not available to arrive at a sound conclusion. I began the appraisal process by inspecting the equipment at two locations in Gaylord, Michigan on January 8, 9 and 10, 2018. During this inspection, given the limitations of a visual inspection, attempted to record and evaluate several factors including but not limited to physical condition, age, estimated depreciation, utility, model numbers, miles, hours, serial numbers, attachments, alterations, upgrades, re-builds, etc., since all of these factors can affect value.



From the resources listed below, I collected data by researching published sales results and equipment manufacturers' and dealers' asking prices. Then using the Sales Comparison and Cost approaches to value, I determined the most probable values for the equipment listed in this report.

Remaining Useful Life

Most of the machinery used in the everyday operations of Pro Source Rent/All, Inc. is in average condition and in working order. It appears to be maintained well to meet the rental industry standard. With normal maintenance procedures and repair, the overall average remaining useful life of the majority of the equipment should be seven to ten years or more.

I attempted to include all of Pro Source Rent/All, Inc.'s major equipment, but I cannot guarantee that all of their major equipment is included in this report.

I made no attempt to ascertain whether the personal property listed herein belongs to Pro Source Rent/All, Inc., or if it is subject to outstanding liens, is rented, borrowed or leased. No allowances have been made for possible liens or encumbrances. This report in no way establishes ownership of this property.

I have assumed that there are no unreported or hidden conditions with this equipment to make it more or less valuable than the reported value. If the age, manufacturer, serial number or other information were not available, I made value decisions by assuming that the equipment is similar to other equipment I have appraised in the past. Some information about the equipment was provided by personnel of Pro Source Rent/All, Inc. and is assumed to be correct. Miedema Appraisals, Inc. does not take any responsibility for the completeness or accuracy of this information.

I did not see all of the subject assets. The items I did not see have an "NS" in the condition column and are listed in the Exhibit A - Equipment Descriptions. I cannot verify if these assets exist or what their condition is. I made assumptions about this equipment based on the assets I did see. These items have been valued on a "Desktop" basis. If my assumptions about them are wrong the values herein could also be erroneous. The information for these items was provided by personnel of Pro Source Rent/All, Inc. and assumed to be correct.

The fluctuating inventory listed in the Exhibit A - Equipment Description was valued using cost information provided by the client. This cost information was assumed to reflect its retail price. Using this this information, I deducted the retail price by 50% to reflect a reasonable discount a dealer would pay for the same equipment to arrive at my Fair Market Values.

The shifting inventory and Craftsman tool boxes are valued in its entirety. All items valued are not listed in the Exhibit A – Equipment Descriptions. The complete list of items was provided by personnel of Pro Source Rent/All, Inc. and is assumed to be correct. The complete list is on file at the appraisers office.



Standard Report Conditions of the Appraisal

The values presented are expressed in USD currency.

Each item number in the Exhibit A - Equipment Descriptions is valued as one lot unless otherwise noted.

Exhibit B of this appraisal report contains a representative sample of some pictures of the machinery and equipment listed in the Exhibit A – Equipment Descriptions.

Conditions of the Equipment

The condition of the items in this appraisal report is determined only through observation. The following defined conditions will be used to make our analysis of the value of the equipment described herein.

New (N) - This describes a piece of equipment that is new and has never been used.

Good (G) - This term describes those items of equipment that are capable of being used to their fully specified utilization for its designed purpose without being modified and without requiring any repairs or abnormal maintenance at the time of inspection or within the foreseeable future.

Average (A) - This term describes those items of equipment that have seen normal wear and tear for their age or have been modified or repaired and are being used at or near their fully specified utilization.

Fair to Average (F-A) – This term describes those items of equipment that have seen above average wear and tear for their age but are still operating near their fully specified utilization. This term is also used to describe those items that are older or have cosmetic defects and deficiencies but are still functional and are being used at or near their specified utilization.

Fair (F) - This term describes those items of equipment that are being used at some point below their fully specified utilization because of the effects of age and/or application and which require repairs and some replacements of minor elements in the foreseeable future to raise their level of utilization to or near their original specifications. This term is also used to describe those items of equipment that are older, nearing the end of their normal useful life or show high hours/miles for their age.

Poor (P) - This term is used to describe those items of equipment that can only be used at some point well below their specified utilization, and it is not possible to realize full capability in their current condition without extensive repairs and/or the replacement of major elements in the near future.

Scrap (S) - This term is used to describe those items of equipment that are no longer able to be used to any practical degree regardless of the extent of the repairs or modifications to which they may be subjected. This equipment has been used for 100% of its useful life.

Not Seen (NS) - This term is used to describe those items of equipment not inspected by the appraiser. Descriptions and information for this equipment is obtained from other sources, and the value is established from the source's general condition description and normal valuation methods.
