For live-in caregiver Maria Tajon, winning her labour board case was proof that the "truth prevails." It also, she believed, meant she'd finally receive almost \$28,000 in unpaid entitlements from her time working in a wealthy Toronto neighbourhood.

But a year and a half on, the temporary foreign worker is empty-handed and homeless, relying on her friends and the shelter system to survive.
